School Mission and Program

1. What is your understanding of the school's mission and guiding beliefs?

The mission of the school is to provide a college preparatory education inside a safe, peaceful atmosphere to kids grades 8-12. The school will value student and parent voices, govern itself using the input of multiple stakeholders, and teach students how to work together and how to resolve conflicts with words rather than with fists. The school believes that all kids can learn in the appropriate educational environment, and that high expectations coupled with precise, effective supports can advance student achievement.

2. What is your understanding of the school's proposed educational program?

The proposed educational program will be academic and college-preparatory. Students will be trained as mediators, will participate in student government, after-school activities and sports, and will be expected to go to college after graduation from FCS Wilmington.

3. What do you believe to be the characteristics of a successful school?

A successful school is one that provides a top-quality curriculum inside an effective pedagogy; where adults and kids learn all the time and even from each other; where parents and community members join arms with school staff to enrich opportunities and experiences for kids; where kids are known by name and need and kids' needs are met, all while safety and positive school culture all flourish and grow. A successful school governs itself democratically and, in fact, helps foster the principles of democracy inside all stakeholders.

4. How will you know that the school is succeeding (or not) in its mission?

The board and school leadership team will align around a specific set of performance goals aligned to our mission. These goals will be measureable, and will be measured quarterly. Board and school leaders will review quarterly data to determine where improvements need to be made.

The board will be involved in building and steering the long-range mission of the school, but will not be included in its daily activities except as the Head of School sees fit.

2. Provide a forecast of where you see the school after its first year of operation and then again in four years.

Based on my experiences in Philadelphia, the first and second year will be critical, and very demanding. With the school growing its population over the first four years (336 students in Year 1, 448 studeths in Year 2, and 560 students in Year 3), it will not be until Year 4 that the school will be able to develop a solid, steady rhythm. It will take time for systems to be established and inculcated. Parents, staff, and students will take time to know and trust each other, but over time will do so. With each additional year under its belt, the school will get stronger and more effective and efficient.

3. What specific steps do you think the charter school board will need to take to ensure that the school is successful?

The board will need to support the Head of School in all ways, including not second-guessing him, while also taking a lead on the strategic vision and analysis of progress and performance on all goals set. The President of the Board and Heads of School will need to be in very close contact, communicating on all fronts; they will need to develop a trusting relationship with one another. The board will also need to leverage resources, access and build partnerships, as well as spread the mission and vision of the school.

4. How would you handle a situation in which you believe one or more members of the school's board were acting unethically or not in the best interests of the school?

If a member of the board were to act unethically in any way, they would need to resign or be removed from the board. Further, all board members must be on the same page about the mission and vision of the school in order to be on the board at all.

Year one will also be our baseline year in terms of academics – learning where the kids are in aptitude and what needs to be learned/strengthened.

Four years later student achievement will reach or exceed state and national averages, thus closing the achievement gap. Our school's culture will be well established and maintained by teachers and students both.

Our board will need to recruit the best and brightest Delawareans to serve. We'll need to work closely with staff leadership to craft a short term and long term strategic plan. Expectations of board volunteers must be clearly communicated - we need to work to be sure each member of our board is productive and carrying out well defined roles. As a board team, we'll a process in place to assess our own performance. As we create a chart of work for our board, appropriate standing committees will be created - Governance, Academic Excellence, Finance, Development, etc.

Prior to joining our board - potential new board members must be made aware of our operating code of ethics. Continued open communication is paramount. Freire Charter School's mission is to develop in young people a grasp of, and appreciation for, the life of the mind. Students will learn to discover and develop their own interests and strengths, and to apply the fruits of their intellectual development to the world around them. The school's guiding beliefs are based on the work of Paulo Freire, and center around envisioning each student as a whole and valuable person, who must be an active participant in the development of his or her own mind.

2. What is your understanding of the school's proposed educational program?

Paulo Freire believed that all human beings are naturally endowed with knowledge, and that the role of those of us who are called to work as educators is to facilitate students' participation in an active and mutual learning process, not to pour knowledge into students' heads. Freire Charter School's educational program is based around the firm belief that when students are provided with a safe, challenging, and mutually respectful environment in which to pursue their own intellectual development, they are capable of incredible academic and personal acheivement.

3. What do you believe to be the characteristics of a successful school?

A successful school is one where students are interested in coming to school, and excited about the time that they spend there. At a successful school, faculty are knowledgeable and caring facilitators who are invested in each individual student's development of their full potential. Freire Charter School will offer a rigorous educational program that holds its students to high standards of achievement, and ultimately prepares them to succeed in college.

After its first year, I anticipate that Freire Charter School's leadership will enter a period of deep reflection and planning for the future. During this period, school leaders will carefully examine data from the school's first year of operation; engage in conversation with students, parents, and teachers about what did and did not go well and what adjustments could be made; and finally, plan and execute any adjustments that will bring the school closer to achieving its central mission.

After four years, I expect that the school will have developed a solid base of educators who are committed to the school and enjoy the working environment there. I anticipate that Freire Charter High School students will be producing proficient or above proficient test scores, and that consistent growth and improvement will be visible in the school's performance.

In order to ensure Freire Charter School's success, the school's board will need to establish timelines and expectations for the school's growth, and undertake regular evaluations of the school's progress towards those goals. Our first group of seniors will have gone away to college, and the Leadership Team and Board of Directors will continue to modify the school's educational program as needed in accordance to state regulations and the best interests of students.

3. What specific steps do you think the charter school board will need to take to ensure that the school is successful?

The charter school board will need to be sure that it stays true to the mission of the school. Furthermore, the board should ensure that the school's financial and governance structures are secure and that the Leadership Team is qualified and receives the necessary training and support. Lastly, the school's governing board must monitor and assess the school's performance towards academic goals in order to evaluate its success and where the school needs additional support.
