As 2011 amended school AYP reports are finalized, for the first time 94% or 17 of 18 Griffin-Spalding County schools met or exceeded standards and made AYP. 17-1 – an excellent wonloss record.

The 2011 AYP standards are higher standards that students are meeting or exceeding than those in 2003 or 2006 when 14 of 17 schools made AYP. Because the benchmarks have continued to rise each year, this year's achievement is even more meaningful.




Closing the Achievement Gap

Criterion Referenced Test (CRCT)

The Criterion Referenced Test (CRCT) is designed to measure how well elementary and middle school students acquire the skills and knowledge described in the Georgia Performance Standards (GPS). The assessments yield information on academic achievement at the student, class, school, system, and state levels. This information is used to diagnose individual student strengths and weaknesses as related to the instruction of the GPS for grades 3–8 and to gauge the quality of education throughout Georgia.

GSCS Performances on CRCT by AYP Subgroups (2003-2011)






Georgia High School Graduation Test (GHSGT)

Georgia's graduation tests provide valuable information for students, educators, and parents about student strengths and areas for improvement. The tests identify students who may need additional instruction in the concepts and skills required for a diploma. Since 2004, the English Language Arts and Mathematics high school graduation tests have been used to measure Adequate Yearly Progress (AYP) under the No Child Left Behind legislation.

All students seeking a Georgia high school diploma must pass the Georgia High School Graduation Tests (GHSGT) in four content areas as well as the Georgia High School Writing Assessment. These assessments ensure that students qualifying for a diploma have mastered essential core academic content and skills.

GSCS Performances on GHSGT by AYP Subgroups (2003-2011)





Graduation Rates


In 2011, GSCS had a graduation rate of 74.1 percent. Spalding High School had an 88.8 percent graduation rate, which was the highest in its history. And Griffin High School saw an eight percent increase in its graduation rate of 73.5 percent.

2003-2011 Graduation Rates by Various Demographics






Adequate Yearly Progress (AYP)


2003-2011 Number of GSCS Schools Making AYP

Georgia Work Ready Initiative

The Georgia Work Ready initiative is a project of the Governor's Office of Workforce Development. The Griffin-Spalding County School System is partnering with the Griffin Spalding Chamber of Commerce and Southern Crescent Technical College to involve all stakeholders in making Spalding County a certified Work Ready community.

Last year, 459 Griffin-Spalding seniors took the national WorkKeys® assessment that measures core skills in applied mathematics, reading for information and locating information. All but nine percent received a nationally-recognized Work Ready Certificate which shows they have the skills to be successful in the workforce immediately after graduating from high school.

"Growth Opportunity Day" in January saw over 750 employees voluntarily attend this first-ever professional learning conference funded by federal grants, corporate sponsors, and designated state funds.

2011 graduating college-bound seniors were offered more than \$4 million in scholarships from local organizations and higher education institutions.

National Foreign Language Exams

A Spalding High School senior was named to the State School Superintendent's Student Advisory Council.

Three Kennedy Road Middle School students placed in the national C-SPAN Student Cam competition in 2010 and 2011.

A Griffin High School student received a national Congress Bundestag Youth Exchange Scholarship Recipient to spend a year studying abroad.

Jackson Road Elementary and Cowan Road Middle received national recognition from the Alliance for a Healthier Generation.

Jackson Road Elementary and Cowan Road Elementary received Fresh Fruit and Vegetable Program grants from the U.S. Department of Agriculture.

Moore Elementary earned an honorable mention from the Georgia Conservancy's Environmental Education Alliance for its new outdoor classroom.

Principals and central office leaders were selected to make presentations at the Griffin RESA conference and the School Improvement Grant conference.

A Mainstay Academy teacher was named a Fulbright Fellow.

Griffin High School was awarded a School Improvement Grant of \$4.5 million over three years.



Beaverbrook Elementary School received a \$5,000 Lowe's Toolbox for Education grant to build a nature trail next to the school.

Griffin-Spalding County School System received the Certificate of Achievement for Excellence in Financial Reporting award by the Government Finance Officers Association for the fifth consecutive year.

Griffin-Spalding County School System was selected to be one of 26 Race to the Top school districts in Georgia, receiving \$3,160,619 to support an approved scope of work that does not supplant state or local funds.

The Griffin-Spalding School System was selected by **Georgia's Pre-Kindergarten** division in Bright from the Start Georgia Department of Early Care and Learning to receive an \$80.000 Transition Coach Grant.

The Special Education Department was recognized for the fifth consecutive year by the Georgia Department of Education for having students with disabilities in a general education setting for 80% of the time.


The school system received the **Georgia School Public Relations Association Award for Best in Category AV** for its "Children First Always" video, which is on GSCS TV online (2009).




