

# The Beginning of a Colony

"Hello James, be a dear and go establish a new colony for me."

"Yes your Majesty. It shall be a grand colony to reflect your splendor."

- <u>King George II</u> of England gave <u>James Oglethorpe</u> a charter to establish another British colony in <u>1732</u>.
- During this time the colony of Georgia, named after the king, was led by <u>trustees</u>.

3. Oglethorpe wanted Georgia to be a safe haven for the <u>Protestants</u>. He wanted to create another colony where Protestants could freely practice their religion. 4. Lastly Georgia was established under the assumption that the <u>land</u> and <u>climate</u> could support some of the goods treasured in Europe.



# Savannah


- The city of <u>Savannah</u> was founded in <u>1733</u>.

- This permission came in the form of the Charter of 1732.
- This meant that for 20 years Georgia would be controlled by the Trustees.



# Tomochichi



- Chief of the <u>Yamacraw</u> Native Americans.
- Helped established peaceful relations between the
  - <u>Native Americans</u> and the <u>English</u>.
- This led to effective trade, safer interactions between the two groups, and a blend of cultures.



- Tomochichi even met the <u>royal family</u> in England.
- Tomochichi was given a <u>military funeral</u> when he died in 1739.

# The Early Settlers of the Colony The Salburgers = Protestants that were expelled from Salzburg. King George II and the Georgia Trustees sympathized with the Salburgers and invited them to move to Georgia.

# The Early Settlers of the Colony

## 2. The <u>Moravians</u> = Protestants from Bohemia.

- Unlike the Salburgs, who were kicked out of their country, the Moravians were missionaries.
- Many other Protestant sects did not trust them as they had a conflicting ideology.
- They believed that women should be allowed to preach to open congregations and hold religious offices.
- Ultimately this group of missionaries was unsuccessful.

- 3. The <u>Malcontents</u>=Highland Scottish colonists that founded Darien.
  - This group of settlers did not receive aid from the Trustees because the were wealthy enough to afford the voyage to Georgia.
  - For this reason they were not as loyal to the Trustees or King George II.
    - The Malcontent wanted to purchase more land and use <u>slaves</u> to acquire more wealth.





#### **Cause and Effect Flow Chart**

**British ships** were smuggling goods from Florida and the **Spanish** threatened these sailors. Causing **Oglethorpe to** want to go to battle.

The Georgians were invading Florida in hopes of gaining Saint **Augustine.** They were loosing and had to retreat. The Battle of the **Bloody Marsh** was the changing point in the war.

**Oglethorpe and** his soldiers and the Highland Scots were able to ambush the **Spanish Causing** them to retreat back to Florida and they stayed their for years to come.

  - Land could only be passed on to a male heir

### Georgia: a Royal Colony

- The Trustees' charter for the Georgia colony ended in 1752.
- Two years later Parliament passed Georgia's new charter that made it an official royal colony.

### Royal Governor #1

- John Reynolds (1754-1757)
- Former naval officer turned ineffective colonial leader:
  - Angered his cabinet
  - made political divisions within the colony
  - Did not have a good relationship with the Native Americans
  - Was removed from his position when residents complained about him.

#### Royal Governor #2

- Henry Ellis (1757-1760)
  - Set up an effective budget for the colony
  - Regulated trade with the Native Americans
  - Built forts
  - Tried to abolish slavery
- Henry Ellis by comparison was a far more effective governor than Reynolds.
- He left the office due to poor health.

#### Royal Governor #3

- James Wright (1760-1776)
- Had experience as a attorney general had Ellis' government officials to help him lead Georgia.
- The peace settlement made after the French and Indian War granted Georgia lands from the St. Mary's to the Mississippi River.

### Changes in Land Ownership

- During this time the wealthy had to have a present family member or servant for every 50 areas of land.

## Slavery

- Was Slavery allowed in Georgia when Oglethorpe was the Governor?
- While the land was divided so that everyone would have a plot equal to the amount of family they brought many of the wealthy colonists wanted more.
- These people demanded that they would be permitted to have slaves.
- In 1750 the Trustees gave in and lifted the ban on slavery.

### Slavery

- Between 1750 and 1775 the number of slaves in America increased from 500 to 18,000.
- Slaves could not...
  - Marry
  - Live where they wanted
  - Leave their slave owner
  - Learn to read
- They were used to cultivate the rice fields of Georgia.
- If they tried to revolt against their masters they could be beaten, separated from their family and friends, and even put to death.
