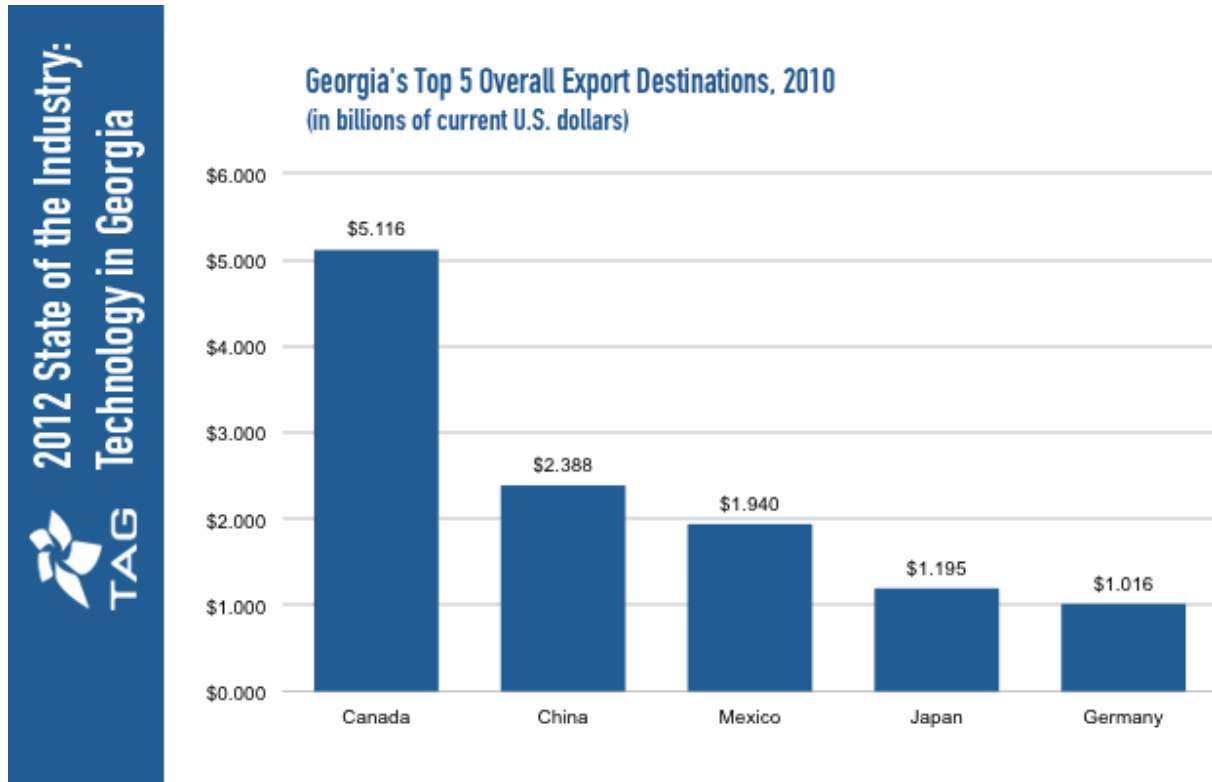

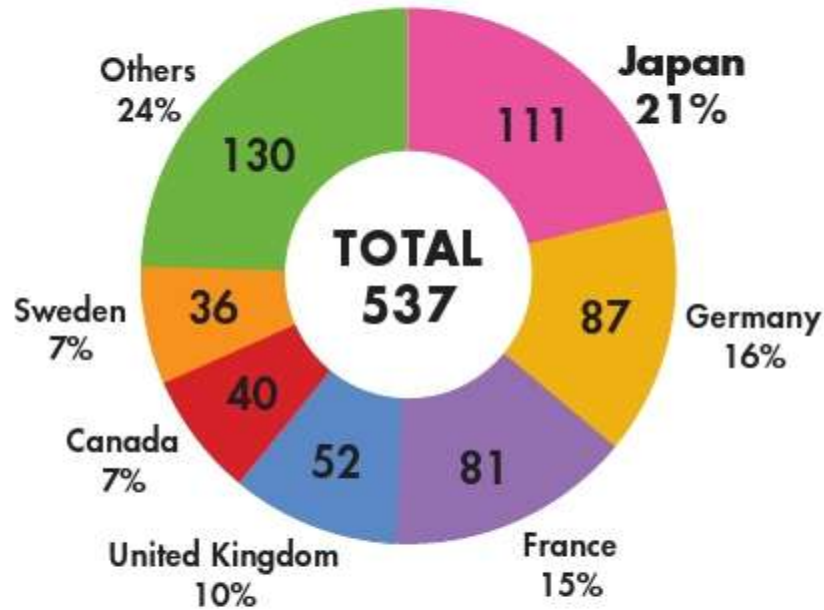

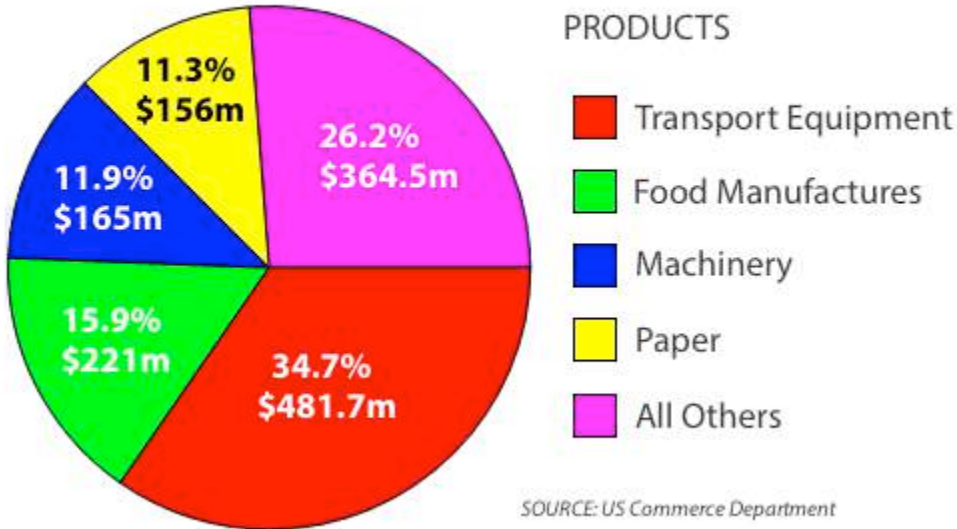

Georgia's Exports to Africa in 2013



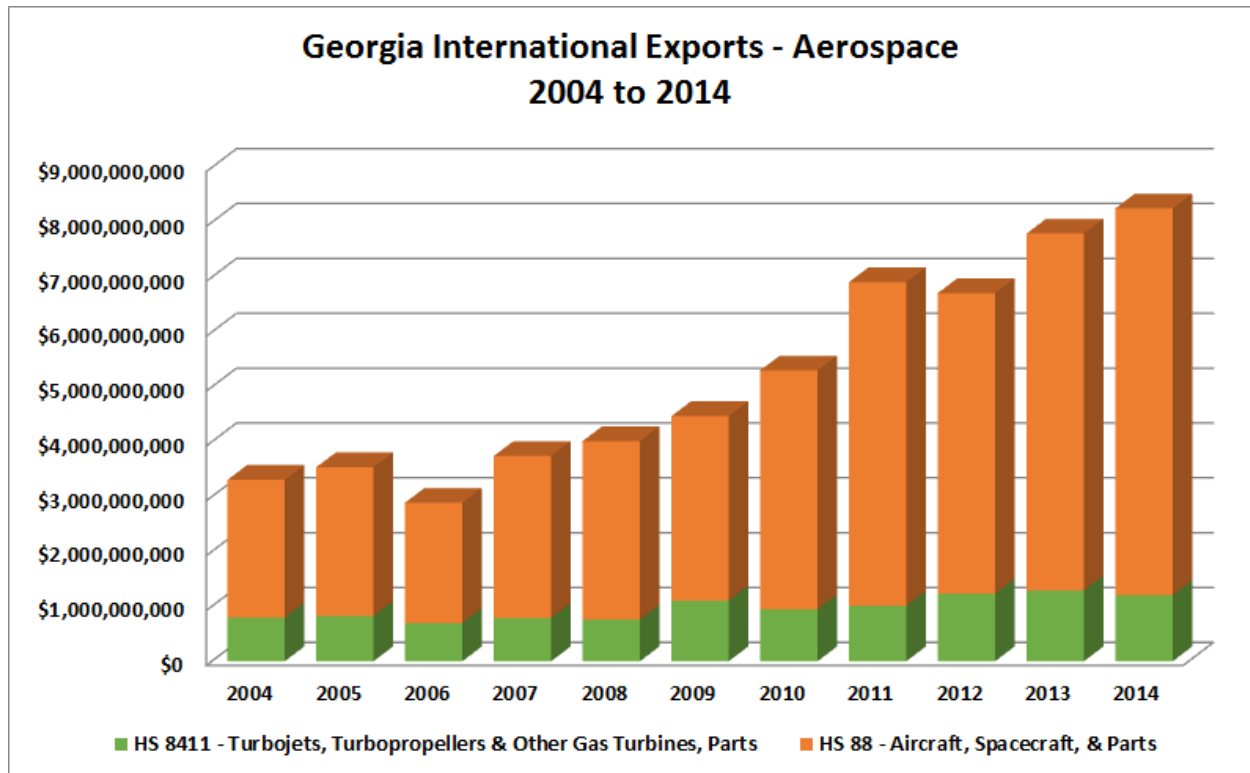

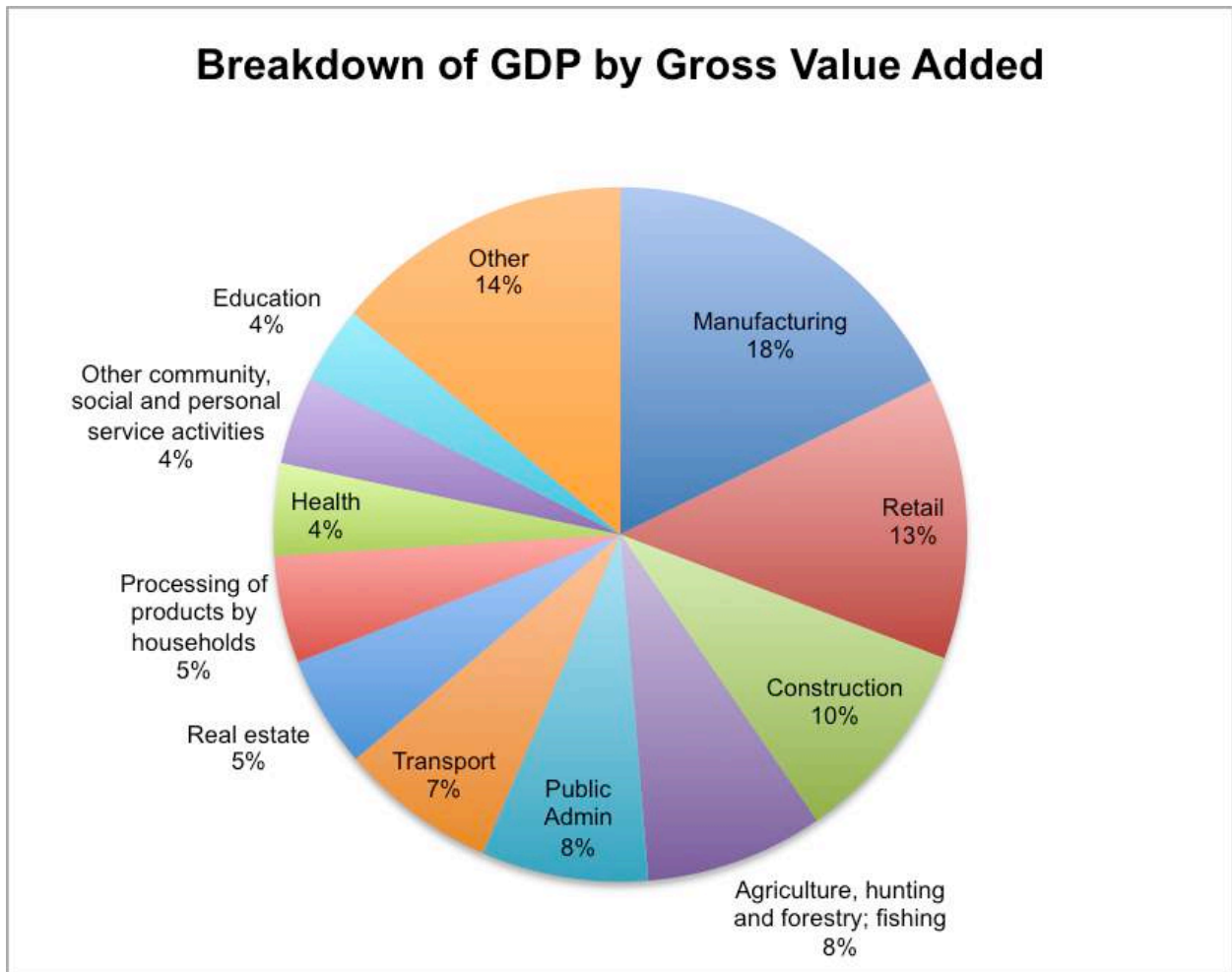

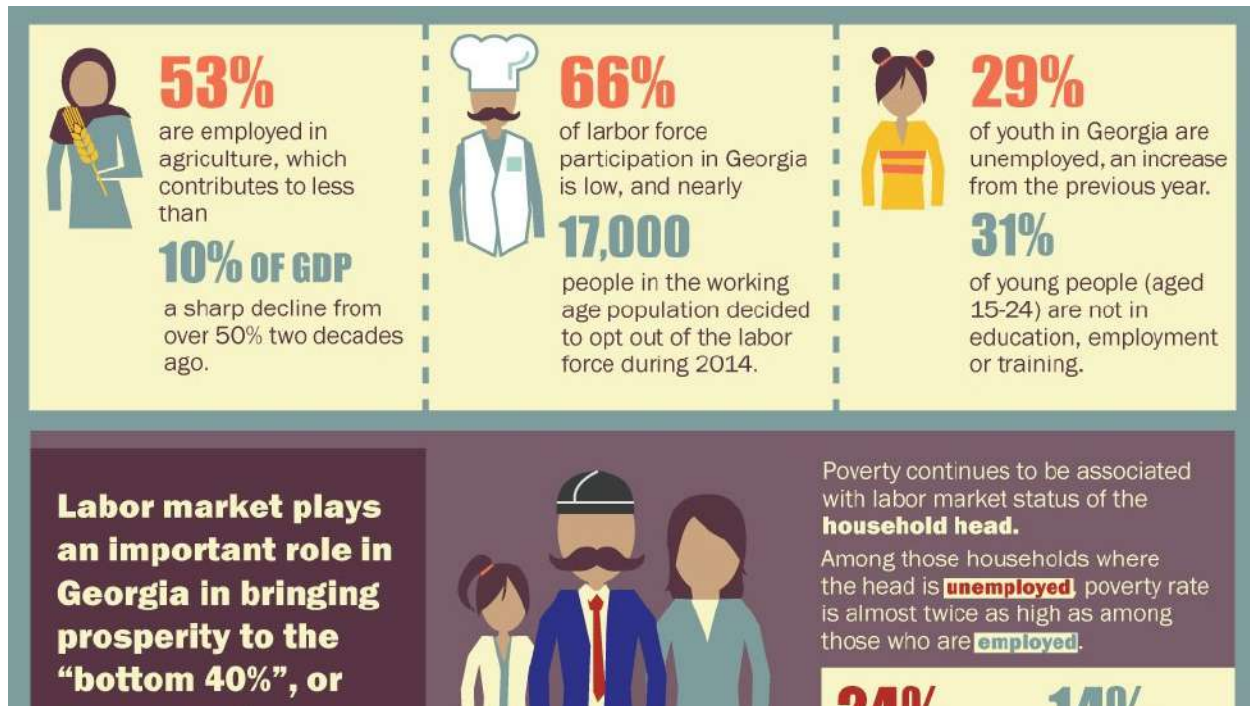

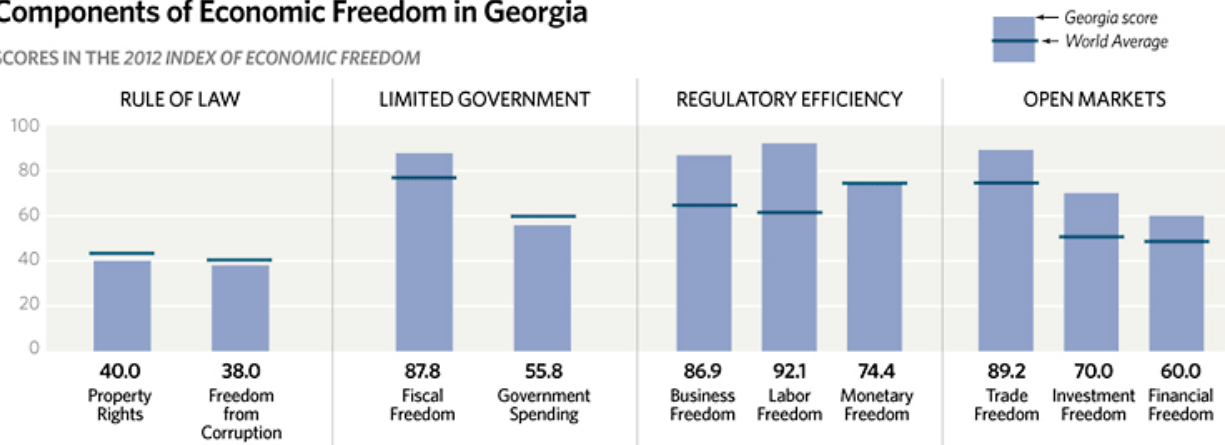

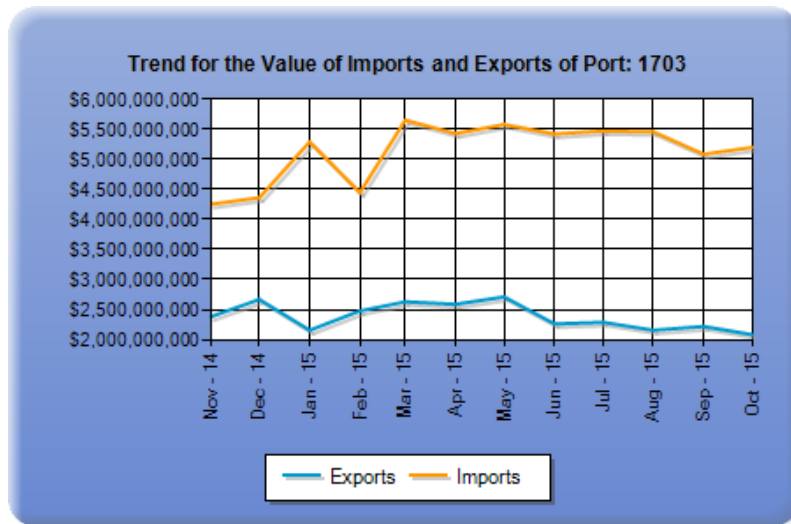
