SPP Indicator 14 Now Available

The SPP Indicator 14 Post School Outcome Data Collection web application is now available on our website and can be accessed at the following link: <u>Post School Outcome Data Collection</u>. The *Hbug Login* and *Password* is required to log into the Post School Outcome Data Collection web application. To locate the *Hbug Login* and *Password*, simply log into *iePoint* > 2016 and click on *File* -> System Maintenance -> View Site Configuration.

Districts selected to administer the survey in 2016 will be offered the choice to use the existing data collection tool or use an expanded survey that will allow youth to provide additional information on their postsecondary education, employment and independent living, as well as how high school prepared them for adult living. Since this is the first time with this option, we recommend viewing the training video prior to determine which form your district would like to complete. Indicator 13 Warnings to Errors

Due to the new Indicator 13 format, data from *iePoint* > 2015 was not migrated to the new Indicator 13 form during the update to *iePoint* > 2016. Currently, a WARNING is received for students with missing Indicator 13 data, however, these will become ERRORS after the May 6^{th} transmission. Now is the time to be obtaining updated Indicator 13 data for students that have not yet had this information completed. It is imperative that districts be proactive in this data collection/data entry in order to be prepared for the June 30^{th} FACTS Approval transmission.

Harrisburg Project has created a report to show which students still have incomplete Indicator 13 data. To access this report log into *iePoint* > 2016 then go to *File -> Print Report -> Student -> Indicators -> Indicator 13 Status Report*.
