FACTS & Personnel Approval Transmissions - Due 05/06

There are <u>10</u> working days until the May 6th required *FACTS* & *Personnel Approval* transmissions. Permissions are now on for these transmissions. You may transmit as many times as necessary until the end of business on Friday, May 6th. Remember, if you are a member of a Super Site, the Super Site may have designated an earlier due date.

iePoint>2016.1.7 Released

Harrisburg Project has released *iePoint>2016.1.7*. This release included improvements to the I-Star Import file creation process. *iePoint>* will automatically receive this update upon logging into the program, however, an *iePoint> Manager* will have to complete the update process.

Percent Special Education vs Educational Environment

Percent Special Education reflects the amount of time for which a student receives special education services under his or her Individualized Education Program (IEP) at the time of entry into the special education program as compared to the total amount of time in the student's regular instructional day. The instructional school day is NOT "bell to bell" and should omit passing periods, lunch, and recess unless the student's IEP requires support during those times.

Example:

John receives 950 Special Education minutes per week. Total instructional minutes per week = 1,680. (950 / 1680 = .565)*100 = 56.5 or 57% Special Education

Percent Special Education has no impact on Educational Environment Codes or the percent spent inside the regular classroom.
