IEP/ISP Indicator Change for 2018 School Year

Due to feedback from a recent webinar, the IEP indicator in SIS is changing to Individual Plan for School Year 2018. Slides 149-150 have been updated on the End of School Year 2017 and Planning for School Year 2018 presentation and reposted. This change will have less impact on districts and local Student information system packages. To view the webinar, click the link below:

IEP Indicator is changing to IP Indicator (Individual Plan):

- 01 IEP/ISP (Any student that is IEP/ISP 01 and Private School Student Yes (PSS 01) will be considered to have an ISP
- 02 None

IP students will have one Service Provider identified for each enrollment:

- Service Provider will default to the Serving RCDTS
- Serving RCDTS code that uniquely identifies the school/program where a student is being educated.
- Service Provider is the entity providing services to the student and may or may not be the serving location.
- Service Provider data may be updated either online or batch only by the home district with the active enrollment.
- Service Providers can update only Student Course Assignments.
- Future enhancements will allow Service Providers to request Student Course Assignments.

Students Attending Summer Term - Updated Information

Public school students attending Summer school should be listed as term of "B" for both. Serving Schools do not need to be changed in I-Star if the student is attending a different attendance center due to the district only have one location open during the Summer session.
