Private Facility Student Reimbursement - Manual Method

The private facility reimbursement is completed differently in I-Star than in *iePoint*>. The Manual Method of Computing Days should be selected when entering reimbursement information in I-Star. The following fields will be required in order to achieve an "approved" claim record:

- % Sp Ed
- FTE
- Enrolled/In Session
- Cost per Pupil

Unlike in *iePoint*>, you are unable to create calendars for Private Facility students in I-Star. You will need to enter the "Enrolled" days manually.

When entering the "Cost per Pupil", you should enter the total amount billed for the Regular and Summer term. The amount billed by the facility should not exceed the per diem times the days in session.

If districts provide transportation for a Private Facility student, the district may claim this amount on the *Student Transportation Claim Reimbursement System* if related service of 25 is listed in the IEP and on the *FACTS Approval* record.
