

I-Star Errors and Resolutions - Funds B, E, F

The following tips have been released by ISBE to help resolve common errors on Funds B, E, F approval records:

- F-027/F-025 Eligibility Verification is NOT complete/Eligibility items Missing/Invalid Orphanage (Fund E/F) students do not match data from DCFS for a time period. Do not change the Fund code to remove these Errors! The verification file from DCFS is updated monthly and my clear up errors. You will be contacted by ISBE if additional action is needed.
- F-007 Residential Private Placement is NOT approved for this student (Fund B/F only) If the student approval is Tuition only, Room & Board Payer field should be I None. If the student approval is Combo or Residential, this error indicates there is a mismatch with the 34-37 residential approval record. Contact ISBE @ 217-782-5256.
