SIS Enrollment Now Available in I-Star

It is no longer necessary to log into SIS to view a student's SIS Enrollment when trying to determine the cause of the following I-Star Student Approval errors:

- F-145 Student not found in SIS for Resident RCDT
- F-146 Student not found in SIS for Serving RCDT
- F-147 No SIS enrollment available for provided date(s)
- F50 Student enrollment not found in SIS for school year

To access a student *SIS Enrollment*, click the 'Display SIS Enrollment' box from the *Student Approval* record, as shown below. The *SIS Enrollment* information will reflect the information closest to the *Student Approval* begin date. For additional SIS questions, log into your SIS account for a more detailed enrollment history.



The following fields in SIS and I-Star must match in order to avoid or correct one of the above errors:

- RCDTS for Home in SIS = Resident District in I-Star
- RCDTS for Service Provider in SIS = Serving District in I-Star
- RCDTS for Serving in SIS = Serving School in I-Star

Private Facility *Student Approval* records are now being error checked against the Serv RCDTS in SIS. The following example shows what fields are error checked on a SIS Enrollment vs I-Star *Student Approval* record:

2017-18 Special Education Private Facility Correction Period Extended

ISBE has extended the correction period for 2017-18 Special Education Private Facility Claims and the 2017-18 Room and Board claims.

The correction period for 2017-18 Special Education Private Facility claims will now end on October 31, 2018.

The FINAL 2017-18 Room and Board claims are due to ISBE via the Special Education Room and Board Claim available on IWAS on Thursday, November 1, 2018. Outstanding 2017-18 claims not received by November 1 will forfeit any reimbursement due.

2017-18 Special Education Excess Cost Payment

The 2017-18 Special Education Excess Cost payment has been calculated and vouchered on September 25, 2018 to districts that had submitted reimbursement records for eligible students.

The statewide breakdown of the students, claims, reimbursement and proration are provided in the table below, a historical summary can be viewed on the <u>Special Education Excess Cost</u> <u>Historical PDF</u>.
