## Fund Code B Student Claims Due August 15<sup>th</sup>

The Fund B *Student Approval and Student Claim* records will be collected at the end of business, Thursday, August 15<sup>th</sup>! **Remember, Fund Code B Student Claims are for Regular and Summer term.**

Helpful hints when completing the Fund B *Student Claim* record:

- Change school year to 2018-2019 from *Student Claims* Filter (screen should be Salmon)
- Search by Fund B to view eligible students
- Enter claim information based on the [Fund B Student Claims Instructions](#)
- Run 'Recheck Edits' from the *Student Claims* Filter
- Run the 'Student Claim Errors by Resident District and Serving School' report from the Report Tab. Select Fund B and Error Type Fatal in the Report Filters
