

December 1 Child Count Data Snapshot

The December 1 Child Count Data Snapshots will continue each Friday in February! The FINAL December 1 Child Count Data Snapshot pickup will be at the end of business, February 26th! No further edits will be allowed to a *Student Approval* record that is included in the December 1 Child Count. The *Student Approval* data will be READ ONLY, February 27th - March 11th!



Special Education Child Count Certification Process

The district superintendent or authorized district representative (with admin access in IWAS) from each school district will complete the Child Count Certification. The certification period will open March 12th. If you are a member of a Special Education Cooperative, they WILL NOT do this for you!

The district superintendent or authorized district representative that will be completing the certification should review the weekly 'Child Count Snapshot' report for accuracy. Once the FINAL snapshot is completed on February 26th, no edits can be made to the December 1 Child Count numbers. Please be proactive and discuss this data with your special education staff today to avoid an inaccurate December 1 Child Count being reported.

- ♦ Delete students not receiving services in the 2019-2020 school year
- ♦ Check for Students Turning 6, 10 (with Disability N) and/or 14 1/2 by running the provided reports under report category 'Reminders'
- ♦ Recheck Edits from Student Approval search page
- ♦ Correct any Student Approval errors that appear on the 'Student Approval Errors Listing' report found under report category 'Errors'
- Review the 'Child Count Snapshot by Resident District' report found under report category 'Approvals' each Friday
