1 MS. NAGOURNEY: Good evening. I  
2 declare this public hearing to be open. Am I  
3 loud enough?

4 My name is Jennifer Nagourney.  
5 I am the Executive Director of the Charter  
6 School Office of the Delaware Department of  
7 Education, and I've been appointed by the  
8 Secretary of Education to conduct this public  
9 hearing. The Delaware Academy of Public  
10 Safety and Security has submitted an  
11 application for the renewal of its charter.  
12 The recommendation of CSAC was renewal with  
13 conditions.

14 At this point, I would like to  
15 introduce my partner.

16 MS. HICKEY: My name is  
17 Catherine Hickey. I'm the Deputy Attorney  
18 General with the Department of Justice -- of  
19 Education, but I represent the hearing officer  
20 in this matter. Thank you.

21 MS. NAGOURNEY: We are expecting  
22 Donna Johnson, Executive Director of the State  
23 Board of Education momentarily. She is  
24 delayed on her trip from Dover, and she will



1 be here as soon as she can -- from Dover.

2 This joint public hearing is  
3 being held by the Department of Education and  
4 the State Board of Education to assist in the  
5 decision of whether the charter should be  
6 renewed.

7 This hearing also provides the  
8 schools and the public with an opportunity to  
9 provide comments for the record.

10 I would like the record to  
11 reflect that the notice -- that notice of the  
12 time, date and place of today's public hearing  
13 was published in The News Journal and the  
14 Delaware State News. In addition, notice was  
15 posted at the Charter School Accountability  
16 Committee's official place of business, on the  
17 Department of Education's official Website,  
18 and on the State Public Meeting Calendar on  
19 the State's official Website.

20 A court reporter is present so  
21 that a hearing -- sorry, a record of this  
22 hearing can be made. It will be necessary for  
23 each speaker to clearly identify himself or  
24 herself before beginning to speak so that the



1 court reporter will be able to note who you  
2 are. The record of this hearing will be  
3 provided to the Secretary of Education and  
4 members of the State Board of Education,  
5 together with any written or electronic  
6 comments received at or before this hearing.

7 We will proceed in the following  
8 manner: First, we will hear from any  
9 representatives of the charter who wish to  
10 comment. Then we will take comments from  
11 anyone else who desires to speak. I have in  
12 my hand the sign-up sheet for speakers. Is  
13 there anything else who would like to sign up  
14 or speak? Okay.

15 We ask that you keep comments to  
16 three minutes for individuals, five minutes  
17 for groups. I tend to be as liberal as time  
18 and reason allow accepting comments. However,  
19 I do reserve the right to limit comment if it  
20 is purely repetitive or cumulative.

21 At this point, we welcome  
22 comments from any representatives of the  
23 school.

24 MR. HUGHES: Good afternoon.



1 Good afternoon. My name is Charles Hughes. I  
2 want to thank the Charter School  
3 Accountability Committee for their fair and  
4 exhaustive review of our application for  
5 charter renewal. We are proud to have this  
6 committee recommend our charter for renewal.  
7 The committee's public concerns for our growth  
8 and development of our academy include a  
9 continued focus on academic achievement and  
10 financial stability.

11 Two areas where our record  
12 reflects an absolute attention toward  
13 improvement and growth, to which, when voting  
14 to renew the charter, the committee gave  
15 testimony.

16 DAPSS is a unique high school  
17 program. We are teaching cadets to save lives  
18 and push them to achieve academically. It is  
19 a readiness blend -- career and college --  
20 with great potential and promise, and we  
21 applaud the Charter School Accountability  
22 Committee for recognizing this effort and look  
23 forward to the support of the State Board of  
24 Education.



1                   We are requesting and confident  
2           that the State Board of Education will support  
3           the renewal of our charter. We are proud that  
4           our school has been supported by over 30  
5           var- -- by over 30 state responder -- first  
6           responder agencies, and believe their support  
7           brings further evidence to the State Board of  
8           Education as they move ahead in support of our  
9           charter renewal. Thank you very much.

10                   MS. NAGOURNEY: Okay. Next, Amy  
11           Novosel.

12                   MS. NOVOSEL: Hello. My name is  
13           Amy Novosel. My son, Jonah Novosel, attends  
14           DAPSS. And I just wanted to speak in support  
15           of DAPSS. We've found it to be a small school  
16           environment, which Jonah really needed. He  
17           had a heart condition last year, and the staff  
18           was extremely supportive. And while he was in  
19           the hospital, he couldn't wait to get back to  
20           school and take his finals, which the teachers  
21           were very understanding about and adjusted for  
22           him. So for him to be a sophomore in high  
23           school and wanting to get back to school says  
24           a whole lot.



1 But another reason why I really  
2 wanted to speak in support of DAPSS is Jonah  
3 isn't interested in being a first responder or  
4 in the public safety field, but it still works  
5 for him and is helping to prepare him for  
6 college. So I just wanted to make sure that  
7 everyone is aware that it's a great school,  
8 not just for those interested in public  
9 safety, but for those who might be college  
10 ready. Thanks.

11 MS. NAGOURNEY: Thank you. Mary  
12 Bryant.

13 MS. BRYANT: Hello. My name is  
14 Mary Bryant and I am a freshman at DAPSS.

15 (Whereupon, discussion was held  
16 off the stenographic record.)

17 MS. MARY BRYANT: My name is  
18 Mary Bryant from DAPSS Academy. I'm a  
19 freshman there.

20 THE COURT REPORTER: I can't  
21 hear. I'm sorry.

22 MS. MARY BRYANT: My name is  
23 Mary Bryant from DAPSS Academy. I'm a  
24 freshman, and public safety is one of the





1 classes we take there. We are learning CPR,  
2 and it is really -- it's really cool to be  
3 learning something like that, since one of the  
4 things I want to become when I grow up is an  
5 EMT. And they teach us all different kinds of  
6 things, how to become a firefighter, first  
7 responders, generally. And we have a fire  
8 school where we learn how to -- learn all  
9 about what the firefighters do.

10 It's really cool to learn about  
11 this kind of stuff. It's -- you won't find it  
12 in regular schools, and it's definitely --  
13 something else that we get to do, TAC OPs.  
14 It's my first year. I've only been a part of  
15 it for a few weeks now, but so far, I'm really  
16 enjoying it. I get to do PT once a week, and  
17 we get to go to different events and we brief  
18 about them, and we have our own class and we  
19 learn a bunch of different things.

20 And it's just really neat to be  
21 a part of something like this. Something that  
22 I wouldn't have had a chance to at my older  
23 schools or any other high school that I know  
24 of. That's it.



1 MS. NAGOURNEY: Thank you.

2 Next, Marissa Dill.

3 MS. DILL: Good evening. My  
4 name is Marissa Dill. I'm a 9th grader at  
5 DAPSS. So far, this year has been really good  
6 for me. At my old school, I had a really  
7 rough time paying attention in school or just  
8 overall succeeding. And I didn't have many  
9 people who were there to support me. But at  
10 DAPSS, the teachers really pushed me to my  
11 limit and so does TAC OPs.

12 I really like it so far. The PT  
13 that we attend is -- it's hard, but it helps a  
14 lot. And I just like to try my best. And at  
15 my old school, it wasn't very -- the teachers  
16 didn't really show any effort into pushing me  
17 to do my best. But at my school that I go to  
18 now, they push me. They really want us to  
19 succeed, and they really -- you can tell that  
20 they like their job. They do a good job at  
21 it. And that's all.

22 MS. NAGOURNEY: Thank you.

23 Tyler Stern.

24 MR. STERN: Good evening. My

1 name is Cadet Master Sergeant Tyler Stern. I  
2 am a senior at the Delaware Academy. I have  
3 been there since the doors opened in 2011. I  
4 am also part of the Tactical Operations  
5 Command. From my experiences, I have enjoyed  
6 every single moment I've been at DAPSS. I  
7 have received training and certifications I  
8 would not have received at any other public  
9 high school.

10 As part of TAC OPs, I have been  
11 certified in many of the IS certifications,  
12 including effective communications. And,  
13 currently, we are being certified in emergency  
14 planning. We have an EMT program where we're  
15 actually going to be certified, and the goal  
16 is to be certified at the national level. So  
17 not just within the state of Delaware, but any  
18 other state in the country.

19 So that's something to be proud  
20 of. Most schools don't offer that. They have  
21 just the normal core classes, natural studies,  
22 reading, science. Well, we have public safety  
23 courses. That's something that makes our  
24 school unique. We receive training with



1 criminal justice dispatch. We go through the  
2 New Castle County Junior Police Academy.

3 Fire school for 11th grade, you  
4 actually go and do the fire school -- they  
5 have a fire company that donates -- not  
6 donates, but volunteers their time and comes  
7 out and monitors us and instructs us on how to  
8 do this, how to do that, how to do the  
9 ladders, how to do the ropes, how to do the  
10 hoses. And that's something you don't get to  
11 do every day.

12 9th grade year fire prevention,  
13 you learn CPR, and we've actually had cadets  
14 use that training out in the real world  
15 already. We've had 12 kids -- 12 cadets get  
16 the lifesaver award. Some of them aren't --  
17 most of them aren't with the fire company.  
18 Most of them were just out there in the  
19 everyday world and they saw an emergency  
20 happen, unfold right in front of their eyes  
21 and they acted. That was part of their  
22 training.

23 So within The Delaware Academy  
24 of Public Safety and Security, they actually



1 show you what to do in the first responder  
2 field and give you opportunities to do it.  
3 Thank you.

4 MS. NAGOURNEY: Thank you.

5 Karina Perez.

6 MS. PEREZ: Good evening. My  
7 name is Karina Perez. I go to the Delaware  
8 Academy of Public Safety and Security. I'm  
9 currently in my sophomore year, and, honestly,  
10 I love my school. I love everything that it's  
11 for. I love all the certifications that we  
12 take, because it -- honestly, it pushes us to  
13 be better than any other school out there. We  
14 get so many more certifications, so many more  
15 things that people -- when you're in college,  
16 you can add to your applications and your  
17 resumés that make you stand out from any  
18 other -- any other kid that applies.

19 You can -- with TAC OPs, you get  
20 so much more certifications. You get all the  
21 FEMA certifications you take when you are  
22 actually going through public -- police  
23 academy. You already have those. You can --  
24 you take all the fire school, you take EMTs.



1 You just -- it's a beneficial school for  
2 everybody and -- just in general. And I love  
3 my school.

4 So with TAC OPs, I -- it pushes  
5 you to be the best you can be. It is a little  
6 stressful, but at the same time, it's to push  
7 you to be the best of your ability. And it's  
8 an amazing program. It's an amazing school.  
9 And why wouldn't it want -- why wouldn't we  
10 renew the charter? Why not?

11 So that's it. Thank you.

12 MS. NAGOURNEY: Thank you.

13 Is there anyone else who desires  
14 to speak? That's a tough act to follow. If  
15 not, the hearing is now closed.

16 I would like to thank you all  
17 for participating today. The secretary will  
18 consider your comments as part of the  
19 decision-making process. Your comments will  
20 also be available for the State Board to  
21 consider. Thank you.


