Dr. Puzzo discussed the November 30, 2018 and December 31, 2018 Statement of Budgetary Activity reports. Budgets are on target. December's budget reflects preliminary budget amounts due to final budget not being approved in January. Once the final budget is reviewed and approved those budget lines will reflect the approved final budget figures. It was noted that the Tax Collection Comparison Report had column title changes to reflect the difference between the tax collection and deposit date for each month.

- State Revenue
 - Increase in Minor Cap funds from the state
 - Increase in Safety & Security from grant
 - o Increase in Transportation
 - Increase in Competitive State Grants
 - Increase in Division III
- Federal Revenue
 - Increase in competitive federal grants
 - Increase in Title IV
 - Increase in IDEA B
- Expenditures were adjusted to reflect the changes in revenue

All funds have been budgeted and there is a balanced budget. Dr. Puzzo anticipates the biggest challenge for this year's budget will be increases in HVAC repairs.

Dr. Puzzo also reviewed the February 1, Financial Position Report.
