Dr. Puzzo highlighted that the expense and revenue reports were based on the preliminary budget. Once the final budget is approved the updated budgets will be reported next month. The balance of state funds will be received once reports are submitted to the Department of Education at the end of the month. Major capital improvements show the balance of construction funds to be spent this fiscal year. Dr. Puzzo requested the Board of Education table the Department Expenditure and Cafeteria Report until February's meeting. It was also noted that November's tax deposit was made in January 2017.

Mr. Dave Helsdon of Richard Y. Johnson & Son, Inc., gave a construction update.

- All 10 contracts have been signed by contractors and the school district and have been distributed
- District is processing contract documents for issue of state purchase order for each contract
- Contractor submittal process is underway
- RYJ has obtained county and Town of Delmar building permits. No cost for county permits. Waiting on review fee cost from Delmar Building Code
- RYJ has had two progress meetings to discuss logistics and scheduling of the different areas of construction with the contractors
- Roof replacement will be the 1st order of business pending favorable weather conditions and school testing schedule
- Demolition scheduled to start January 23 in areas that will not disrupt students
- RYJ received architectural, MEP and structural drawings from BMG today to the athletic building. Civil drawings and specifications to be completed soon. RYJ will start the pricing phase of the building but will need completed documents to finalize pricing

• Criminal background checks are being received for all contractors. Badges are to be worn and a log book will be kept in the construction trailer.

Dr. Puzzo discussed the FY'17 Delmar School District Final Budget. The preliminary budget was based on a projection of units. Once the unit count was confirmed Delmar School District dropped 3 units. Certain state funds are unit driven. Those funds include: Division II AOC, Division II AOC Vocational, Division II Energy, Division III Equalization, Technology Block Grant, and Sustainment Funds. Due to a decrease in units the funds have decreased approximately \$63,000, reflecting the difference from the preliminary budget and final budget. Projections for state salaries increased approximately \$12,000, which will be covered by state funds. The increase in the debt service tax receipts is approximately \$70,000, due to an adjustment in the projected carryover from last year. Those funds can only be used to pay down bonds. The projected E-Rate carryover funds were also adjusted by approximately \$20,000, reflecting the difference from the preliminary and final budget. E-Rate funds are restrictive and can only be used for approved technology projects. Discretionary Revenue Budget references the changes made in the Final Revenue Budget. Expense budgets did not change with the exception of local salaries.

A motion to approve Business Item 8.5 Approval of FY'17 Final Budget was made by Thomas Elliott, seconded by Jason Coco and carried unanimously.

Dr. Puzzo explained the financial position report process. The purpose of the report is to show that the district has enough money to cover one month's local payroll. Delmar School District is in compliance.

A motion to approve Business Item 8.6 February 1, 2017 Financial Position Report was made by Jason Coco, seconded by Farrah Morelli and carried unanimously.
