Mrs. Steele discussed the FY'16 Preliminary Budget. The budget has a 6% increase from FY'15. Increases in local operating expense and formula salaries were included. Expenses increased in maintenance and grounds for local construction fund reserve. The athletic budget increased based on addition of 2 new sports. After the September 30<sup>th</sup> unit count the budget will be adjusted and up for final approval.
