June 26, 2018 Meeting Minutes

The regularly scheduled meeting of the Delmar Board of Education was held on the above date at the Delmar School District. The meeting was called to order by Shawn B. Dr. Puzzo discussed FY'19 tax rates. The recommendation was broken down as follows:

Debt Service will be decreased by \$0.0850 since the construction bond payments have decreased. Tuition needs to be increased to cover the cost for a special education student receiving educational services at a residential program. Delmar is responsible for 30% of the student's tuition. The state will pay 70%. The state is increasing its minor capital improvement allocation for FY'19; therefore, in order for Delmar to match the required 40% in local funds, Minor Cap must be increased by \$0.0650. This will allow Delmar to collect the additional state Minor Cap funds.

With the proposed FY'19 Tax Rate Change the average homeowner will see no increase or decrease this year.

Mr. Elliott asked if Minor Cap would cover the cost of the repairs to the courtyards that are not covered by construction funds. Dr. Puzzo stated that minor cap is typically budgeted for facility maintenance and repairs, but it could be budgeted to repair the courtyards.

Dr. Puzzo distributed a spreadsheet breaking down Debt Service tax year to year. Taking the balance from the previous year and adding to tax collection plus senior property tax collections give the total amount available to pay down bonds. Districts are only allowed to carryover 4 months' worth of bond payments which is approximately \$49,000.00. If Debt Service is not decreased we will exceed the amount needed which will likely result in an audit finding.
