

If a student currently has an IEP or 504 Plan with testing accommodations, there is an additional separate application process for requesting accommodations for both the College Board (SAT, AP, PSAT) exams and the ACT. College Board and ACT will review the request, then approve/deny accommodations for their respective test(s). A current IEP or 504 Plan does not guarantee approval of accommodations for these exams. The final decision is up to College Board and ACT.

What to do if a student already has approved accommodations with ACT and/or CollegeBoard through another high school:

If a student already has approved accommodations via CollegeBoard (PSAT, SAT, AP) with another high school, the student should provide the school counselor with the following information, and we can transfer the student to the Beachside CollegeBoard accommodation system: Students 10-digit SSD number and student date of birth. If a student already has approved accommodations with ACT through another school, students MUST call ACT and request to transfer their accommodations to Beachside High School. Call 1-319-337-1332 (option 3), ask for the students' accommodations to be transferred to Beachside High School (code 102813). What to do if a student has never applied for accommodation with ACT and/or CollegeBoard:

What to do if a student already has approved accommodations with BOTH the CollegeBoard and ACT:

If a student already has approved accommodations via CollegeBoard with Beachside High School, students can view their decision letter by signing into the CollegeBoard account. Students will use their SSD number each time they register for an SAT test online.

If a student already has approved accommodations via ACT with Beachside High School, students should select 'yes' when prompted to confirm they need accommodations after beginning the ACT registration process.
