VI. INFORMATION ITEMS/REPORTS

- a. Superintendent Report
 - i. Recognize Lisa Sherick from ISBA. Lisa has been training our board members for the last year. We, as a board, want to say Thank You for all of your help!
 - ii. Boys Basketball has come to an end. The boys finished the season out with a win at White Pines.
 - iii. Student, Staff, and Parent Survey from SDE: All of our students have participated in the survey, but not a lot of parent participants.
 - iv. New School Bus arrived in February. We have just received all of the paperwork, plates, and registration to be able to start using the new bus.
 - v. SDE Transportation Spot Inspection was also in February. Swan Valley Elementary was at a 98.5% pass rate. Lloyd Sorensen from SDE came in and went through financials, paperwork, and driver files and everything looked great.
 - vi. HVAC Update: Pressure test is scheduled for Spring break. Mr. Jacobson and David Palmer (maintenance) met with the engineer and there may be a need for a bigger transformer. The board had a discussion regarding the different sizes of transformers, III phase power, and upgrading pipes and ducts.
 - vii. SVFD Air Quality Test: Fire Chief Crystal came to the school and did an air quality test. The school has no leaks HVAC system. This test shows that we have no air quality concerns.
 - viii. Asbestos Management: It has come to our attention that Swan Valley Elementary should have an asbestos management plan. After lots of digging and several hours of looking for paperwork we found that an asbestos plan was created in 1988. In this plan they have an inspection set for every three years. We have scheduled an inspection for March 18th. and we will get back on an inspection routine.


