II. OPEN DISCUSSION

- Bellview Middle School IT Career Academy - Superintendent

Students enrolled in the Information Technology (IT) Career Academy at Bellview Middle School addressed the School Board regarding their experiences in this program.

January 2017

There were no changes to the School Board's schedule of workshops/meetings for January.

February 2017

Special Meeting re: Out-of-Field Teachers – At the request of the Superintendent, School Board Members agreed to schedule this session for February 3, beginning at 2:30 p.m., in the Superintendent's Conference Room, at the Dr. Vernon McDaniel Building, 75 North Pace Boulevard. Joint Meeting with Escambia County Board of County Commissioners (BOCC) – The Superintendent said that County Administrator, Mr. Jack Brown, had contacted him regarding the Escambia County Board of County Commissioners' desire to host a joint meeting with the School Board for discussing common concerns of both agencies. School Board Members agreed to submit February 14, beginning at 9:00 a.m. and February 27, beginning at 5:30 p.m., as a potential dates/times for that session.

- NSBA Conference March 25-27 - Moultrie

Mrs. Moultrie reminded her fellow School Board Members to let the assistant know if they planned to attend the National School Boards Association (NSBA) Conference, March 25-27, in Denver, Colorado.

- <u>Feasibility of a Language Immersion School</u> – *Hightower*

The Superintendent asked Mrs. Hightower to give his staff approximately sixty days to research the feasibility of establishing a language immersion school in Escambia County.

- <u>Graduation Rate Presentation</u> – <u>Superintendent</u> [Handout provided to School Board Members]

Two of School District's graduation coaches, made a brief <u>presentation</u> regarding graduation rate. Ms. Lesa Morgan, Director of Secondary Education, credited the graduation coaches with helping to increase the graduation rate to 76.1% (a 10% increase over the past two years) by working closely with the schools. Following the presentation, the Superintendent responded to questions posed by School Board Members regarding various matters/topics affecting graduation rate. School Board Members expressed their appreciation for the information and data provided in the presentation and handout. Mrs. Moultrie asked that future reports on graduation rate highlight the graduation trend data for African-American students.

- AdvancED Update - Superintendent

At the request of the Superintendent, staff reviewed information with School Board Members intended to prepare them for the upcoming AdvancED Accreditation Team visit, February 5-8, 2017.
