I. CALL TO ORDER

Mrs. Moultrie called the Regular Meeting to order at 5:30 p.m.

2. Stellar Employee of the Month

The Superintendent made the following announcement: I am pleased to inform you that the stellar employee for this month is Carl Dunmore. Mr. Dunmore serves our district as the only custodian assigned to the Spencer Bibbs Center and has been employed with the School District for 1.5 years. The Spencer Bibbs Center is a large complex not only housing two substantial departments; Title I and Professional Learning, but is also the main training center for the School

District. This means there can be up to 470 additional people on campus any given day. This requires lots of extra cleanup for all the training rooms in addition to Mr. Dunmore's regular work routine. Yet, he single handedly maintains the building with meticulous detail and does so with a spirit of willingness that is unsurpassed, refusing to go home until the building is spotless.
