- Parking Accommodations for Graduations to be Held at the Civic Center – Hightower
Mrs. Hightower initiated a discussion regarding the parking accommodations for this year’s high school graduation ceremonies to be held at the Pensacola Civic Center June 6th and June 7th. It was noted that graduates and guests would be faced with parking restrictions due to the recently constructed Commerce Park in downtown Pensacola.
- School Board Website Demonstration – Superintendent
Janice Courson, Business Cooperative Education Coordinator-Tate High School introduced two students from Tate High School, who gave a brief demonstration of the webpage that they had designed on behalf of the School Board Office.
- Tobacco-Free Hiring – Superintendent
Mr. Kevin Windham, Director of Risk Management, gave a brief PowerPoint® presentation entitled “Tobacco-Free Hiring Policy: The School Board’s Role in Reducing Cost Associated with Tobacco Use.” It was noted that the Board would be asked to consider advertisement of the proposed “Tobacco-Free Hiring Policy” at the May 17, 2011 Regular Meeting [see: May 17, 2011 Regular Meeting agenda, Item III.B.5, Notice of Intent to Advertise to Adopt Amendments to Rules and Procedures of the District School Board: Chapter 2, Human Resource Services (6Gx17-2.47 – Tobacco-Free Hiring Policy)] Mr. Windham explained that the proposed policy would prohibit the hiring of any applicant who had used tobacco or tobacco products within the six months preceding their application for employment. Mr. Windham believed that the proposed policy would not only mean healthier employees, but also lower costs associated with health insurance costs and lost days at work. He noted that similar policies had been adopted by other large local employers, including Escambia County, ECUA, Sacred Heart Hospital and Baptist Health Care.
- Bullying/Harassment Reporting – Superintendent
Ms. Vicki Mathis, Director of Alternative Education and Mr. Bill Norman, Programmer Analyst I/Web Master, gave a brief demonstration of a new online program that would allow anyone to anonymously report incidents of violence or harassment of students in the Escambia County School District. These incidents would include bullying, teen dating violence, harassment, and other incidents. Mr. Norman noted that the program would be accessible at the beginning of the 2011-2012 school year via a direct link from the District’s website.
