1. High School Diploma Graduation Requirements:

- (a) successfully complete the required credits for the diploma option students have chosen (see school counselor for details);
- (b) pass the state required examinations with the required score or higher as specified for the graduation cohort to which the student belongs, or, if eligible, an approved alternative assessment; and
- (c) achieve the required Graduation Grade Point Average (GPA) of 2.0000 on a 4.0000 scale and other GPA as required for the specific graduation option.

2. Grade Level Promotion Requirements Under the 24 Credit Option: Students will be classified at the beginning of each school year based on enrollment in their 9th grade cohort (i.e. first year in high school - Freshman/9th grade; second year - Sophomore/10th grade; third year - Junior/11th grade; fourth year - Senior/12th grade).

3. Grade Level Promotion for all 9th Grade Cohorts under the 18 Credit Option: Students will follow the grade level promotion requirements of their 9th grade cohort until they are enrolled in the last class(es) required for graduation at which point they will be classified as a Senior/12th grade. Students with a 9th grade cohort prior to 2014-15 must see the applicable Student Progression Plan.

4. Participation in Graduation Ceremonies: Students must satisfy state and district graduation requirements prior to the senior notification deadline set forth in the district student/teacher calendar in order to participate in graduation ceremonies.

5. Grade Point Average (GPA) Explanations:

- (a) The required graduation GPA (State) is the same for both the 24 and 18 credit graduation option. Students must achieve a cumulative unweighted GPA of a 2.0000 on a 4.0000 scale for all courses taken for high school credit unless replaced according to the grade forgiveness policy.
- (b) Class rank GPA will be determined according to policies described in the Student Progression Plan. (H.S. Grading, section V-B, 1)
- (c) The Florida Bright Futures Scholarship Program weighted GPA may be different from the district's weighted GPA as the state recalculates and uses a different weighting system. Parents and students should utilize the State of Florida website Florida Shines at <https://www.floridashines.org> and/or consult with their school counselor to determine current Florida Bright Futures GPA and State University System GPA.

6. Course Failure: A quarter grade of D or F in a class indicates that the student is at risk of failing the course. Immediate contact with your child's teacher or school counselor is recommended.

7. Information reported is based on the current year's Student Progression Plan and State Statutes. Please contact your child's school counselor for advisement services.

8. For information regarding the effect of district finals and state End of Course (EOC) examinations, please contact your child's school counselor.
