Information Technology Security (ITSEC-AS) – Career Pathways Agreement between Pensacola State College

The Escambia County School District

THIS CAREER PATHWAYS ARTICULATION AGREEMENT is entered into by and between THE DISTRICT BOARD OF TRUSTEES OF PENSACOLA STATE COLLEGE, FLORIDA, hereinafter referred to as the "College," and the George Stone Technical Center as part of the Escambia County School District, hereinafter referred to as the "District," in order to establish and validate an articulation agreement which supports the implementation of a Career Pathway.

WHEREAS, the Florida Department of Education has adopted educational opportunities under the Carl D. Perkins Career and Technical Education Act of 2006 (Sections 122 (c) (1)(A)and Section 135) to more fully develop the academic and career technical skills of students who elect to enroll in career and technical education (CTE) Programs of Study; and

WHEREAS, to accomplish the Program of Studies requirements the parties hereto have recommended that students enrolled in core academic and CTE courses beginning at the secondary school level through a complementary postsecondary component shall have the opportunity to receive postsecondary credits applicable to their post-secondary program of study credential to ultimately include, but not limited to, a certificate, advanced technical diploma or associate of science degree provided, however, that students meet the minimum requirements and conditions herein set forth below; NOW THEREFORE,

FOR AND IN CONSIDERATION of these premises and other good and valuable consideration, the College and the District do hereby agree and covenant each with the other the Career Pathway as follows:

Successful completion with a grade of "B" or better in all of the following postsecondary level coursework or attainment of appropriate state-recognized industry certification.

- 1. The District's Program of Study/Career Academy and required core course/s:
 - a. Network Support Services Program
 - b. OTA0040- Information Technology Assistant (150 hours)
 - c. EEV0504 Computer Support Assistant (150 hours)
 - d. CTS0022 Network Support Help Desk Assistant (150 hours)
 - e. CTS0023 Network Support Administrator (150 hours)
 - f. CTS0024 Senior Network Administrator (150 hours)
 - g. CTS0029 Wireless Network Administrator (150 hours)
 - h. EEV0317 Data Communications Analyst (150 hours)

College credit will be awarded upon request to the student for the following courses:

- 2. The College's Program of Study, required course(s), and number of college credits:
 - **Cybersecurity (ITSEC-AS)**
 - a. CET1178 PC Hardware (A+) (3 College Credits)
 - b. CET1179 PC Operating Systems (A+) (3 College Credits)
 - c. CGS 1061C- Introduction to Computers in Technology (3 College Credits)
 - d. CIS 1350C- Security Awareness (3 College Credits)
 - e. CTS 2120C- Security+ (3 College Credits)
 - f. CET 1588- Network+ (3 College Credits)
- 3. Minimum requirements and conditions for students:
 - a. Complete the postsecondary school course(s) listed above with a final grade of B or higher.
 - b. Complete fifteen (15) college credits at the College in courses other than the course(s) stated in 2.a., 2.b., 2.c., 2.d, 2.e, and 2.f. above within two (2) years from graduation from the District in order to receive the college credits in 2.a., 2.b, 2.c., 2.d., and 2.e., and 2.f. above.
 - c. College credits for coursework defined in 2.a., 2.b, 2.c., 2.d., 2.e, and 2.f. above cannot be awarded if the requesting student attempts those course(s) at the College.
 - d. Waivers to this Agreement will be initiated through the College CTE/Career Pathways Office.
- 4. The initial term of this Articulation Agreement shall be from_____, to____, whereupon, this Articulation Agreement shall automatically renew annually for four (4) consecutive years, unless either Party gives written notice at least sixty (60) days prior to the commencement of any renewal term that it does not intend to renew the Agreement. If neither Party gives notice of its intent not to renew, it shall be deemed by both Parties that no modification was needed and that this Articulation Agreement has been ratified by the College and the School Board. If a party to this Agreement does give notice of its intent not to renew because some modification is needed, then the Parties will jointly consider the proposed modifications and, upon reaching an agreement, they will enter into a new Articulation Agreement which shall include such modifications.
