## FAQ: Personnel Begin & End Dates in iePoint>

Q: I entered an End Date on Personnel who are no longer with us but still received an error from ISBE. Why is that?

A: Only yellow fields in *iePoint* > are reported to ISBE. Personnel Begin & End Dates are white fields in *iePoint* > and are therefore NOT transmitted to ISBE. All *Personnel Approval* records included in your database are transmitted to ISBE. Personnel who are no longer employed in your district should either have the 'Report in Personnel Approval' box unchecked or be deleted. Please keep in mind that Personnel who were employed for the previous Summer Term or part of the Regular Term should remain in the database in order to be claimed at the end of the year.
