FACTS & Personnel Approval Due Friday, Oct. 10th

There are 4 working days remaining until the October 10th *FACTS* and *Personnel Approval* transmissions.

Don't wait until the last minute, transmit your data once it is error free! Remember, you can transmit your data as many times as necessary until the end of business Friday, October 10th. If you are member of a Super Site, your Super Site may have designated an earlier due date.

IWAS Authorization Deadline

The deadline for completing the IWAS Authorization is Thursday, October 9th. If you are still receiving IWAS Authorization errors, contact the District Superintendent and request that they login to their IWAS account and complete the authorizations.

Once the IWAS Authorization has been completed, be sure to *Refresh Common Data* daily to check for updated information. Remember, there is a 24-48 hour turnaround time for a completed IWAS Authorization to show up in *iepoint* >.

Summer Orphanage Permissions on - Due Nov. 3rd

Permissions are now on to transmit the 2013-2014 Summer Orphanage claim. The Summer Orphanage claim is due by the end of business Monday, November 3rd. If you are a member of a Super Site, your Super Site may have designated an earlier due date.

Remember, this is the final transmission from *iepoint* > 2014.1.5 DATA2014.

November 3, 2014 - Summer Orphanage (Funds D, E, F) Reimbursement Transmission

FACTS Not Reported vs FACTS Transmitted to ISBE

Two reports are offered during the ISBE Reporting process: ‘FACTS Not Reported’ and ‘FACTS Transmitted to ISBE’.

There are three reasons why a student may appear on ‘FACTS Not Reported’.

- The *FACTS* Begin Date is after December 1st
- The *FACTS* End Date is before December 1st
- The ‘Include in *FACTS Approval*’ box is unchecked

‘*FACTS Approval* Transmitted to ISBE’ details all *FACTS* records that are transmitted to ISBE. All current year *FACTS* records are transmitted to ISBE (unless ‘Include in *FACTS Approval* box’ is unchecked) to ensure that all Exit Data is reported.
