### **Overarching Need #1: Many students continue to perform below proficiency in reading and math.**

**GOAL:** By the spring of 2023, at least 60% of students in each grade level (3-5) will meet or exceed their projected growth from fall to spring on the Reading and Math MAP (Measure of Academic Progress) assessment.

#### Describe the Title I program at OCES:

The school-wide program at Oglethorpe County Elementary School will continue to address increasing the rigor of instruction and assessment as required by the state standards. The needs assessment results indicate that progress is occurring in grades 3-5, but there are still gaps between subgroup performances. It was also found that students in higher grades are missing foundational skills in literacy and math as well as background knowledge in science and social studies. Title 1A, Part A monies within Fund 150 will also be spent to provide a teacher and materials for the STEM Lab SWING class. Fund 150 will be utilized to purchase nonfiction leveled supplemental books, differentiated reading materials, math manipulatives, hands on materials for science as well as reading and math software programs and applications (Reflex, Frax, IXL, BrainPop, Write Score, Reading Plus, MAP Assessment, Writing by Design). At-risk students will be provided supplemental literacy and math instruction during their Connections block. A half-time reading teacher will be utilized to provide additional reading support to students performing significantly below grade level expectations. Fund 150 monies will be used to provide evidence-based interventions and professional learning. Partnerships with parents will continue through parent meetings held throughout the school year. Supplies (for example: copy paper, folders, spinners, index cards, dry-erase boards, markers, and dice) and child care for parents attending academically (reading, math, science and social studies) focused meetings will be funded through Title I, Part A. These funds will also be utilized to provide professional learning on literacy, math, science, social studies, student engagement, technology integration, and differentiation including registration fees and travel expenses, updating classroom SmartBoards, and subs for teachers. A school-wide literacy initiative, "One School, One Book" will be implemented to encourage and strengthen our community of readers. An after-school and summer school program will be provided to assist students struggling to meet benchmarks. These will be funded through Fund 150 monies. Patriot Games and PATS (Patriots Aiming Towards Success) will be supported through these funds as well as the Student Advocacy program and our Art, Music, PE, and Gifted programs. Career awareness lessons are provided in grades 3-5 by the school counselor. A 21st Century program, ASPIRE, will provide homework help and enrichment opportunities for 75 students focusing on the following objectives: increasing reading and math MAP (Measure of Academic Progress) scores from fall to spring, improve the students completion of homework, and increase school attendance. The program will also strive to have ASPIRE parents participate in family literacy and educational activities and participate in activities that will promote their child's success in school.
