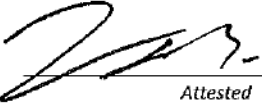
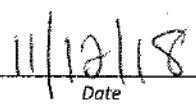
- I. **Call Meeting to order:** Chairman Scholes Called meeting to order at 7:04 pm and led the Pledge of allegiance.

  - a) Mrs. Poole motioned to adopt the October Agenda. Mrs. Scholes seconded. 2 in favor 0 opposed. Motion carried.
