Ideas for Standards 5 & 6 (Describe the structure and interaction between Law and Public Safety Agencies) (Demonstrate understanding of the missions, strategies policies and management styles of LPSCS)

• Students get an overview of each type of department then they are tasked to develop the following over 2 weeks in class researching real department SOPs, SOGs, websites and other sources

They have to create an Agency or Departme available

- Police (Local or State Level)
- Fire
- EMS
- Emergency Management (County or State)
- Public Health (County or State)
- State Bureau of Investigation



Ideas for Standards 5 & 6 (Describe the structure and interaction between Law and Public Safety Agencies) (Demonstrate understanding of the missions, strategies policies and management styles of LPSCS) *Continued*

- The students then create for their department
 - Name of Jurisdiction and Name of Department Example- Ola Police Department.
 - Mission Statement
 - Command Chart
 - Budget
 - Staffing Chart
 - Hiring Policy and Standards
 - Training Policy and Standards
 - Presentation for the Governing Body (City Council, County Commission, State Budget Committee) AS IF THEY WERE A REAL CHIEF ASKING FOR AN ANNUAL BUDGET!!
 - Describe what other agencies they will work with and what they will do to prevent, prepare for, respond to and recover from terrorism or a terrorist attack)
- This is a fun way to get kids to learn what everyone does and to learn the real world about competition for funds between various agencies and how hospital billing and traffic fines are utilized.

Ideas for Standard 9 (Investigate ethical and legal responsibilities associated with LPSCS professions)

- I do lecture and PowerPoint for several days incorporating role playing examples:
 - Police officer pulls one of them over and gives one driver a written warning and one a ticket for the exact same offense. Talk about discretion, ethics, policies and how they all come into play.
- There are excellent videos on the ethics of police officers in New Orleans who chose to evacuate and take care of family instead of reporting for duty? Moral, Legal, Ethical, Personal Feelings etc.
- Go over all of the vocabulary words (Honor, Duty, Ethics, Code etc.)

Ideas for Standard 9 (Investigate ethical and legal responsibilities associated with LPSCS professions) *Cont.*

- After the kids define all of the vocabulary words (Honor, Duty, Ethics, Code etc.)
- Show them the movie "A Few Good Men". Even though it is not Law Enforcement, it is a perfect example of doing what is right, but not necessarily acceptable or moral and vice versa.



Ideas for Standards 10 -14

- I put my students through the actual CERT course, utilizing all of the FEMA / CERT slides, tests and online testing.
- With all of the material online, the kids can catch up if they are absent or review for exams at their own pace without the teacher having to create more material.

Ideas for Standards 10 -14 Cont.

• For the fire unit, I ask teachers and the community to donate extinguishers that have expired or about to expire. I let students complete the P.A.S.S. drill using a live extinguisher on a fake fire.



Ideas for Standards 10 -14 Cont.

- For Light Search and Rescue I use a googlemaps image of our practice football field and create grid squares. I divide the classes into teams and they are each assigned a grid to search for "Little Dart" which is a green 2.5 inch replica of Darth Vader who has wandered off.
- In addition to search and rescue, the kids learn the Incident Command System, by assigning them as IC and Operations Chief, They establish a Command Post, Complete ICS forms and use radios to practice communications and 10-Codes.


Ideas for Criminal Justice Essentials Standard 4 (Describe the Court System Process of a Criminal Trial)

- Lecture and PowerPoint on the steps from arrest to trial.
- Give the students all of the key vocabulary words.
 (Arrest, Suspicion, Reasonable Cause, Search and Seizure, Evidence, Testimony, Jury Selection, Voir Dire, Expert Witness, Cross Examination, Verdict etc.)

Ideas for Criminal Justice Essentials Standard 4 (Describe the Court System Process of a Criminal Trial)

- Then have the kids watch the movie "My Cousin Vinny"
- Everything covered in this standard is covered in the movie. The kids learn it really well. Show the movie over a 3 day period so you can stop it at the end of each class and review where they are in the process of a criminal trial. NOTE: Get a permission slip from parents. There are about 12 "F" words in the movie. Most parents are ok with it. The kids really comprehend how it works from the movie. Especially "Discovery, Expert Witnesses and Cross Examination".





Ideas for Criminal Justice Essentials Standard

- 11 (Explain the various purposes and different sentences)
 - Lecture and PowerPoint
- Students also wrote specific questions to an actual high profile prisoner who is serving a "Life Without Possibility of Parole" sentence that I happen to know from high school.
- Pam Smart- actually answered all of the kids questions through letter. (Pam was never told kid's last names or personal information.)
- Students debated various types of sentences and were very interested in Pam's efforts to seek a pardon or gain eligibility for parole.
