Privacy and Confidentiality is about the students gender identity, which is to be reflected in student records/school practices in a way that balances both current legal requirements with the student's personal right to self-disclose on their own terms to whomever they choose.

I would petition to this committee that all LGBTQ youth are afforded the same privacy as the three youth who are serving on this Committee.

1	Thank you for the work of the committee in drafting the regulation and policy. It is a good solid step and will do much to ensure the safety of all students in Delaware Schools.
2	I strongly support a policy that ensures that all students, including transgender students, can learn without fear of mistreatment and discrimination. The proposed regulation and model policy is an important first step towards guaranteeing that, but it should be improved in several ways.
	Many students cannot learn properly or even attend school if they don't have access to the right restrooms. The regulation and model policy need to make it clear that all students must have access to facilities that match their gender identity.
	When it comes to most kinds of documents that students use—including school IDs, attendance rosters, and other records visible by the public—there's no law requiring schools to match those to students' legal names. Transgender students should be able to change those records regardless of whether they've had a legal name change. And as for the few records that have to reflect a student's legal name, the regulation should require schools to keep those confidential to protect transgender students' privacy.

57	The following are my comments on proposed changes to Title 14 Delaware Administrative Code 225 The proposed regulatory changes are for the most part illegal and will not withstand challenge in the
	Delaware courts. The General Assembly has specifically not added "gender identity" to Del Code Title 14. Thus, there is absolutely no legal authority for that provision. In addition, many other parts of the proposed regulation should only be enacted after the General Assembly passes authorizing legislation.

There is currently minimal discrimination in our schools. This new regulation and the companion policy are likely to ignite new tensions between the races. After all, if the state government says we need this intrusive new policy, many people are likely to assume they are justified for complaining.

The complicated language and procedures will then practically guarantee constant turmoil among students, confusion and fear by staff of being accused of some sort of undefined discrimination, and endless lawsuits to decide what some of the convoluted language means and how it is to be applied.

Specific Comments

Governor's Memorandum

- The term gender identity is in the first paragraph, where he says it should be included. This is not an order.

-Paragraph 2 is the only action paragraph. The only order is "to create clear guidance.... to prevent unlawful discrimination. Unfortunately, the modified regulation creates guidance that is neither clear nor lawful.

-The requested November 1 date of publication, by use of the word should, is merely a request or suggestion, not an order.

-The rest of the memorandum expresses hopes and suggestions, not orders.

-In any event, a governor cannot create law without passage by the General Assembly, thus his memorandum can not legally demand many of the proposed changes in regulation 225.

Committee work

It is obvious that the committee must have been handed a preconceived policy document to work with. It seems near impossible that such a complex undertaking could have been conceived and finalized in just 3 meetings, over 10 working days, between September 6 & September 19.

How else could everything have been ready for the first public meeting on September 26? That raises the question of whether there was discrimination involving access to the process in the early stages for the benefit of selected members of the public.

Comments on proposed changes to regulation 225

-1.0 Purpose

- "Gender identity or expression" cannot be included without passage of a bill in the General Assembly modifying Title 14 in state code.

- It is said by the Department of Education that each school can devise their own policy, but the last sentence indicates that this regulation may be a minimum standard. How will a district judge how their policy is adequate in only a 90 day period?

-2.0 Definitions

- "Gender identity or expression" cannot be included without passage of a bill modifying Title 14 in state code.

3.4 - Allowing a person to attend the sex education of their gender choice is outside the scope of Delaware law. In addition, it violates the Governor's order of clarity. Will the schools have to provide private, separate instruction? Does this conflict with U.S. Supreme Court rulings that "separate but equal" is still discrimination?

4.1 Does this mean that guidance counselors will have to propose "opportunities" suitable for people with specific protected characteristics. If so, would this be discrimination? Does "depict" mean there will be pictures showing people with various protected characteristics participating. What if there are no pictures? Is that even what this means? This violates the Governor's clear order for clarity.

4.2 As an example, does this mean that the Guidance Counselor must mention that someone with missing fingers could consider playing the clarinet as a profession? There is no clarity.

5.1 At what point do "protected characteristics" start to interfere with student choice? Will schools have to flood students with information just so they can't be accused of a violation by omission?

5.2 Does this mean that schools will have to lower standards for males to be sure that females can meet the same physical standards?

6.3.1.2 Does this mean the district must spend equally for sports that draw thousands of participants and those that draw dozens? Will it cripple or end high profile programs like football? Is this already covered by federal Title 9 requirements?

6.4 The two sentences seem to conflict with each other. The last sentence says, "shall have the opportunity to participate," not "try out." Does this mean only transgenders won't have to try out? Where is the clarity?

6.5 I defy anyone to explain exactly what this means in practical terms. Exactly what kind of teams are being described? There is no clarity.

7.3 How will the school deal with having 2 names in eSchoolPlus? Which name will the student be called by? Will there be punishment for making a mistake?

7.3.1 A The concept that a student can change both gender and name with no parental consultation and involvement is an absurdity and an abuse of the principle of in loco parentis. The child is likely far more influenced by the school than the parents and this is a theft of parental authority that has not been approved by the General Assembly.

7.4 This is in direct conflict with 7.3. At the very least, it is not clear, as the governor ordered.

7.4.1 The concept that a student can change both gender and name with no parental consultation and involvement is an absurdity and an abuse of the principle of in loco parentis. The child is likely far more influenced by the school than the parents and this is a theft of parental authority that has not been approved by the General Assembly.

8.0 This is not clear, as required by the governor. This will result in separate but equal, which is still discrimination. This verbiage will invite an eventual court challenge, leading to the courts setting the policy, not the districts.

9.1 How is it possible that this can be done in the 90 days allotted after promulgation, especially since most districts have had no input into the creation of this regulation?

9.1.1 This is controlled by Del. C 14, not the district's whim.

9.1.2.2 The very existence of this pathway to making a complaint will discourage the making of formal complaints. It could result in major incidents not going through a formal process while other minor incidents of accused discrimination could be subject to the full review process.

9.1.2.3.3 It is impossible to know what this means. Does "if requested by the student" mean the parents will be part of the complaint process or that the students must request parent participation before they will be allowed? There is no clarity. In addition, Just how much of the school's time and energy will have to be invested in complying with this procedure. In effect, it puts the "hens in charge of the henhouse." Large numbers of complaints, or incidents with large numbers of participants, could tie the school administration in knots.

9.1.2.4 This obviously could add to the burden posed by 9.1.2.3.3

10.5 This provision would seem to encourage a person to change their gender identification to qualify for a scholarship normally only available to the opposite of their birth gender.

11.1 Given that school boards usually have only monthly meetings and prepublished agendas, how can they responsibly meet all the requirements this regulation establishes in only 90 days?

- There is no clarity as ordered by the governor when districts are given just 90 days to create a policy that will be different in every district, especially when proposed regulation 225 states that those provisions are the minimum acceptable. How will a district know that their policy is acceptable? What are the consequences if it is not?

- The required language, "No person shall be subjected to retaliation for reporting, testifying, assisting or participating in any manner in an investigation, proceeding or hearing resulting from a complaint of discriminatory behavior" is an open invitation for bad people to falsely accuse, harass, and intimidate their victims, including students and staff. If it is discovered that their accusations are in fact false, no discipline can be applied. How does this not result in chaos and anarchy in many schools?

Electronic Survey

-The electronic survey seems designed to manipulate the feedback the Department receives from the public. The survey has 7 blocks. Two of them ask for 3 positive comments each, two ask for 2 concerns, and two ask for 1 question each. Only the final block is for general comments. If commenters follow instructions, that means you will automatically receive 50% more positive comments than negative, thus artificially inflating support. This is why when I made my comments, I left the first 6 areas blank.

Conclusion

Neither the proposed regulation nor the model policy document are based on authorities given to the Department by the General Assembly of Delaware. That is the basis for changes in the Administrative (Regulatory) Code of the State of Delaware.

The order given by the governor for clarity is not met. In fact, the confusion that will be created if this effort becomes regulation will likely lead to confusion and litigation , especially when people start being accused of discrimination that has not even been defined.

Adequate time has not been given to the school districts or the public to adopt the new district policies that will be required.

Finally, the imposition will lead to many unintended consequences that could lead to heightened racial tensions and other chaos in our schools.

I urge you to back up and take another long look at this before proceeding further.
