PROOF of RESIDENCE – Parent/Guardian must provide proof of residence within the Stevenson School District Boundaries. □ A Rental Agreement, Mortgage Document, or utility bill (electric, water, cable, or landline phone bill) with legal parent/guardian's name and address. □ Notarized letter from the owner/initial renter of the property along with proof of residence attached.
☐ 2. PICTURE ID OF PARENT/GUARDIAN – Driver's License, State ID, or Passport.
 □ 3. TB CLEARANCE - The tuberculin test (Mantoux) or chest x-ray must be performed in the United States or a US Military Base. □ DOE/Mainland/Private School Students - Proof of TB Clearance. □ Foreign School Students - Completed within one (1) year before entry into Hawai'i's school system (preschool or K to 12) performed in the United States or Military Base
 □ 4. HAWAI'I SCHOOL HEALTH RECORD (F-14) - A completed F-14 including a physical examination and all required immunizations or appointment card. □ DOE/Private School Students - Provide proof of a physical exam. □ Incoming 7th Graders must have a new Physical Exam within 12 months of the start of 7th Grade □ Mainland/Foreign School Students - Completed within one (1) year prior to entry into Hawai'i's school system (preschool or K to 12) performed in the United States or Military Base
 5. LEGAL COURT DOCUMENTS - Temporary Restraining Order (TRO), any Legal Name Change Document for student and parent, Divorce Decree showing Legal and Physical Custody changes, Guardianship Documents and/or Power of Attorney (Valid POAs must have an expiration date of less than one year stated in the document). A student not residing with legal guardians/parents, documentation of a valid "Special Power of Attorney" (POA). POAs must have an expiration date (not exceeding one year) stated in the document.
☐ 6. BIRTH CERTIFICATE or PASSPORT - Student's Birth Certificate, Passport, or any other official document to show the date of birth.
 □ 7. *Documentation of release papers and transcript records from school last attended. □ Hawai'i students from DOE (must have a release from last DOE School) or private school. □ Grades of the child's latest report card and a copy of results from the latest achievement Test results. □ Students transferring from out of state and do not have documents should have the name and address of the last schools attended. □ 8. Parent/Legal Guardian living OUT-of-DISTRICT – Must have an Approved Geographic
Exception.
