The Division of Child Support Services (DCSS) provides child support services to Georgia parents who need assistance. The custodial parent may apply at the office that serves their county. There is an application fee of \$25. The custodial parent is asked to furnish legal documents, if available, and information about the non-custodial parent.

Child Support Services include:

- Locating non-custodial parents
- Establishing paternity
- Establishing and enforcing child support orders
- Establishing and enforcing medical support orders
- Collecting and distributing support payments

Enforcement tools available to DCSS:

Withholding child support from paychecks or unemployment benefits; intercepting federal and/or state income tax refunds to pay child support arrears; Garnishing workers' compensation benefits; Reporting parents owing more than \$1000 in child support payments to credit bureaus; Suspending or revoking driver's, professional, or occupational licenses for failure to pay child support; Reviewing and modifying child support orders periodically; Intercepting lottery winnings of more than \$5,000; Filing contempt of court actions which may result in a jail sentence if the non-custodial parent is found in contempt of court; Filing liens and levy on tangible/intangible property;

Seizing matched bank accounts after notice.

Fatherhood Services Network: The Fatherhood Program helps any non-custodial parent paying child support through DCSS who lacks the economic capacity to do so because they are unemployed or underemployed. The program offers job counseling and placement assistance, provides vocational training, educational assistance and classes on parenting, job interviewing and financial management. Gainful, stable employment enables these parents to provide regular financial support for their children.



Child Access and Visitation Program:

This program addresses the needs of non-custodial parents who want visitation with their children. Research shows that parental contact is related to the payment of child support and the father's involvement improves child's development and self-esteem. The non-custodial parent must have an active case with Child Support Services to be eligible for the program.

DCSS does not: Help anyone get a divorce; Find custodial parents; Take legal action about visitation rights or custody; Enforce court ordered payment of unpaid bills not related to child support payments; Help legitimize children.

Children's Medical Services (CMS) is a Department of Public Health program that provides or coordinates specialty medical care services for children with chronic medical conditions in Georgia. Examples of these conditions include:

- Burns, cardiac, chronic lung (including asthma & cystic fibrosis)
 - Craniofacial anomalies (including cleft lip and/or palate)
 - Orthopedic & neuromuscular (including cerebral palsy, scoliosis, & amputations), diabetes, gastrointestinal, hearing
 - Spina bifida, neurological and neurosurgical (including epilepsy and hydrocephalus), vision, (cataracts, glaucoma, amblyopia & strabismus)
- Children birth to 21 who live in Georgia, have an eligible medical condition, and meet income criteria are eligible for the CMS program. These services include: medical/diagnostic testing, specialty medical care and treatment, medications and supplies, Care Coordination, and referral to community resources.

Children's Medical Services also provides specialty clinics for children and youth with special health care needs. These may be on-site at the CMS office or through Telemedicine provided by Pediatric medical specialists. Currently, these include: Neurosurgery, Asthma, Hematology, Genetics, Neurology, and Orthopedics.

The Early Head Start program in Ware County is for children ages 6 weeks to 3 years, including expectant families. Pregnant teens will receive services and when the baby is born, and the baby will take the mother's slot as she continues her education. The program includes developmental screenings, breakfast, lunch, snacks, on demand feeding for infants, parent training activities, diapers/formula/baby food provided during care, low child/staff ratio and more. Early Head Start is a free, federally-



funded program. While there are income guidelines, priority is given to children with special needs, as well as homeless and foster children. The program is licensed and Quality Rated.

The Harrell Learning Center is a special day school dedicated to serving children and youth (ages 5-21) with severe emotional and behavioral disorders (SEBD).

The Harrell Center is a public school and serves those children with severe emotional problems who cannot be properly served in traditional special education classes at their home school.

The Harrell Center offers comprehensive services in small, highly structured settings. SEBD children are typically such a very small part of the normal school population that it would be cost prohibitive for small systems to provide as many as four-to-five adults to work with only one or two children.

The Harrell Learning Center serves students from Ware, Atkinson, Charlton, Clinch, Coffee, Bacon, Brantley and Pierce counties. Students are bussed from their home county and returned home each day.

The Center has 10 classrooms, serving children grades K-12. Class size is limited to ten students, with eight students

being the average class size. Each class has one certified teacher and one para-professional. Additionally, the Center also has a school psychologist, social workers and crisis intervention teachers to deal with students in crisis. The long-range goal is to teach each student sufficient social skills to allow that child to return to their home school.

Students are referred to the Harrell Learning Center through their home school. School personnel, parents, physicians, and/or other service agencies may initiate the referral. Upon referral a social history, psychological (or a psychiatric evaluation) and educational evaluation are completed to help determine the individual needs of the student. The next step is to get the parents, referring school personnel and the Harrell Center staff together to discuss the needs of the child and where those needs might best be met. If all agree that the Harrell Center is the best resource to meet the child's current needs, a placement will be made at that time. The ultimate determining considerations are: Does the child exhibit the presence of a severe emotional disability, over a long period of time and to a marked degree, which adversely affects educational performance?

Children through age 21 whose families have made a move across state or school district borders for this purpose within the last three years are eligible for services. The program works with teachers, school personnel, and other community resources in meeting student needs.

Applicants must be at least 18 years of age and provide proof of age. Proof can be established with a birth certificate or valid driver's license. Must also provide legal documentation of divorce pertaining to any previous marriage. Current cost is \$26.
