Our son has attended Odyssey for two years now, transferring in from our feeder school. We have enjoyed a lot about Odyssey – Odyssey has a more challenging curriculum, with more opportunities for special learning programs and field trips than our son's feeder school. We have absolutely loved the curriculum and teachers he has interacted with during his time at Odyssey. He has been involved with the Green Team, learning about the environment while helping the school improve its use of resources. In addition, the benefit of learning Greek has been an added challenge which helps him learn another language and culture. We feel very strongly that the school is an essential part of our son's success and we are committed to making sure the school continues to flourish. We have been following the emails regarding challenges with the school and unfortunately, we are dismayed by recent events related to our special needs son who the school decided they will place out of school despite their inflexibility getting us the resources we requested numerous times prior to the end of the school year for his special needs education and support. We feel they mismanaged funds to support our son and didn't provide the requested ABA provider to support his behavioral and learning needs despite many requests at IEP meetings. We ended up getting provider on our own recently at our expense.

We are taking our son out of the school into Colonial school district. Thankfully our new home is in this district and as people of color with an international background with prior experience with Greek culture, this school does NOT represent the hospitality and kindness we expected which is why we picked the school in the first place.

We faced hostile comments from special ed teacher, dismissive staff including the principal who walked out of our most recent (thankfully last) IEP meeting and we will pursue action against the school for the deception and unwillingness to invest in our child's education as they should have, we know they have the budget. They had no intention of keeping our son and took a year to build their case while denying him services needed (specifically ABA) to increase his chance for successful continuation at Odyssey.

Please contact us for documentation of our experiences, we are happy to supply all our communication logs and IEP reports as evidence of their inability to support us, they didn't listen and did what they wanted arrogantly deciding for us instead of partnering with us.

Unfortunately, we are unable to attend the public hearing.

Dear Charter School Accountability Committee

Odyssey Charter School was founded because of the collective belief in creating a rich cultural education for students, with a focus on academics, Greek culture, and mathematics. It is AHEPA'S dedication, heart, and vision that have kept this mission alive for the past 12 years, since the inception of the school. The state funding that the school receives for each child goes to academic needs, but it is AHEPA's consistent hard work at fundraising that has helped our community thrive. This includes becoming owners of the school's property, in order for the school to expand from K-4 to K-12.

No other parties have stepped up in bringing those kinds of funds to support our school. In my opinion, the politics and competing agendas of the current principals, the union, and some parents, do not have a place in any school setting. If anything, they have had a negative and confusing effect on the Odyssey community.

When the teachers and administration were hired by Odyssey Charter School, we were all aware of AHEPA's mission and goals, and we made our decision to commit to their vision. Dear DDOE Members –

I am a parent at Odyssey Charter School (OCS) and former OCS Board Member (PTO Parent Board Representative). I am writing to encourage you to require OCS to modify its board by-laws and require AHEPA to have equal, minority or ex officio (non-voting member) representation on the school board. Additionally, the OCS Board President should be appointed by the OCS Board, and have no AHEPA membership requirements. AHEPA should not be allowed to choose the OCS Board President any longer. Based on the information you have to date, you can easily see the abuse of power and mis-use of public monies the AHEPA board members have engaged in.

The public tax monies AHEPA Board Members have funneled into AHEPA initiatives and AHEPA friends, as well as the illegal use of insurance monies should be enough for you to require the OCS Board by-laws be rewritten without an AHEPA majority. Without an official state audit, it is unknown how far back these financial abuses go, but based on my experiences, I believe you will find further wrong-doings by the AHEPA Board Members.

AHEPA has stated if they do not retain a majority on the school board, they will withdraw all support from OCS. While some think this is a bad thing, I believe OCS can use this towards their benefit. I believe OCS would thrive without the AHEPA oversight, and be able to fundraise real money that would go right back into the school where it benefits the teachers and students.

The teachers, staff, students and families are what is important at OCS, and we need a new board make up to support the OCS family. We need a board that will re-examine the organizational structure within OCS, and eliminate the extraneous and over-paid positions that AHEPA has brought into the school. OCS needs a board that will review the various non-academic contractors OCS continues to employ (even though their services are no longer required), and terminate these contracts.

OCS needs a board structure that will support an efficient and lean administration, and allow the Academic Head of School to be the actual head of the school. OCS is not a business like the AHEPA Board Members state. It is a public school, and needs to be run as such.

I am at your disposal should you have questions about my tenure on the OCS Board and the issues I faced as a woman and minority vote/voice on the board.
