Clusters within these Domains are considered part of the Major Work of Grade for Grade 6. Without further documentation (lesson plans, assessments) it is difficult to gage if these standards are being addressed in-depth.
- The Ratios and Proportional Relationships Progression document has been inserted into the unit. This document outlines the coherence that exists between clusters and domains from grade to grade. Without further documentation it is unclear how this information will be used to carry out the unit.
