

**REGULAR MEETING MINUTES**

**August 8, 2018**

The regular meeting of the Board of Trustees of Challis Joint School District No. 181 was held at Challis Middle School, Challis, Idaho 4:30 p.m. on the 8<sup>th</sup> day of August, 2018 as provided in Sections 33-510 and 74-206 et seq Idaho code.

Mrs. Rembelski and Kari Alexander talked about their recent training in Boise. Mrs. Rembelski stated that she is still looking for an a.m. kindergarten teacher, and one Para pro, and that the elementary will be starting one extra day before the contracts starts for an in service day. Mrs. Rembelski reported that the Forest Service is currently renting some land over by the track and middle school building for fire fighters to sleep. Mrs. Rembelski also reported that the district office move is moving right along. She reported that student 1801 reinstated and a plan is in place for him to return to school. Mrs. Rembelski also has created a matrix for the future upcoming hiring process.

**G. BLM Lease:** Mrs. Rembelski gave an update that the BLM is still in the works of taking over the old district office and more land in the back of the Challis Middle School.

**H. Driver's Education:** Mrs. Rembelski reported that the driver's education will be during class for the upcoming 2018-19 school year, and she would like to see the student fee be increased to \$200 for the driving time that will be during after school hours. She also wanted to propose that we increase the hourly wage to \$21.50 for the driving instructor whoever that may be.
