## REGULAR MEETING MINUTES Board of Trustees of Challis Joint School District 181 November 7, 2018

The regular meeting of the Board of Trustees of Challis Joint School District No. 181 was held at Challis Elementary School, Challis, Idaho 4:30 p.m. on the 7<sup>th</sup> day of November, 2018 as provided in Sections 33-510 and 74-206 et seq Idaho code.

The meeting was called to order at 4:30 p.m. Board members in attendance were Brett Plummer, Jim Chamberlain, Terri Stillwaugh and Janiel Parkinson. Trish Farr will be attending the meeting by phone. A rebuilt engine will be \$11,000 plus \$2,500 core disposal plus installation. The engine will be 85% reimbursed with a total reimbursement range from \$2,400-\$5,134.

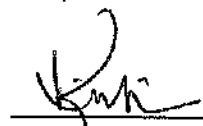
