ACT AND SAT TESTING AT BTHS



- BTHS is an ACT and SAT testing site
- Testing occurs in the 9th grade center
- Students need to arrive by 7:45 a.m. for check in
- Students will have their temperature checked before they enter the building
- Students must present a photo ID and admission ticket at check in
- Students must bring #2 pencils with erasers along with an approved calculator. Check the ACT and SAT website for a listing of approved calculators. Students may bring back up batteries for their calculator

Students must create an account with password. Keep in a safe place as you may need to register for future administrations

IMPORTANT INFORMATION REGARDING SAT TESTING

- All SAT dates are listed on our BTHS website and students can click on the BTHS Guidance link under the tab testing to register
- Students must log on to www.collegeboard.com to register and pay registration fees and upload a photo ID
- The BTHS testing center code for SAT is 10614
- The BTHS school code is 100809
- Please remember to keep username and password in a safe place for future registrations

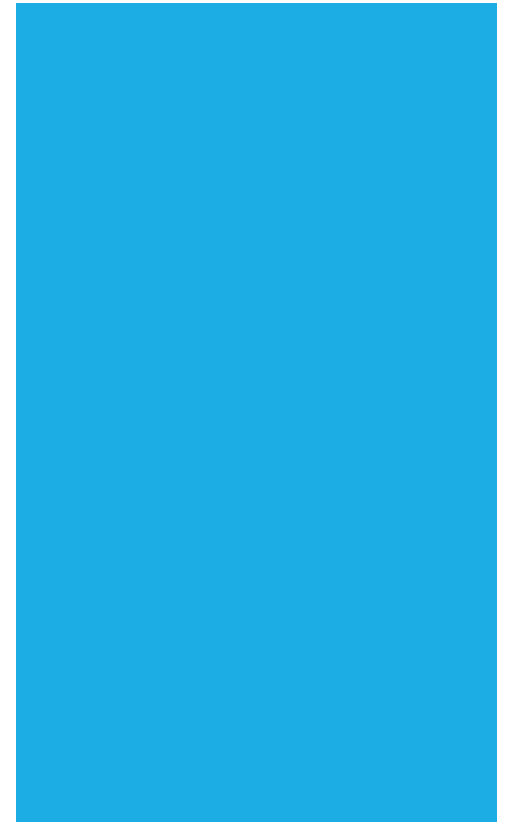

RECOMMENDATIONS:

- It is highly recommended that students begin taking ACT and SAT prep classes to prepare for college admissions placement testing
- A great start is taking PSAT in 9th, 10th and 11th grade in October of each school year. 9th and 11th grade students must pay for the PSAT score reports each year and 10th graders are paid for by the state so each year 10th grade students all take the PSAT free of charge and these results can help target areas where test prep is needed.
- It is a great idea to purchase an ACT/SAT prep book and start preparing
- Free SAT and ACT prep books are in BTHS Guidance for students
- It is recommended that ACT and SAT be taken in the spring of the junior year of high school

ACCOMMODATION REQUESTS FOR ACT/SAT TESTING

Parents of students with IEP's and 504 plans or medical needs please note that there is a special accommodations deadline that is different from the normal registration deadline.

Students must notify their School Counselor if they need accommodations.

A parent consent form is needed for ACT and SAT accommodations

Once the consent is received and testing date is selected the School Counselor will process the paperwork on the testing dashboard for review. ACT and SAT accommodations office will approve or deny the request. Students can only test with accommodations if approved. Both parent and Counselor and testing coordinator will be notified.
