Minutes of the Swan Valley School District No. 92 School Board Meeting 2/12/15

- 1. Call to Order: Chairman Hicks called the meeting to order at 6:37 and led the board and audience in the Pledge of Allegiance.
- 2. Roll Call: Board Members in attendance were: Chairman Tara Hicks, Vice-Chairman Joseph Lundquist, and Trustee Bill Steffes. Others in attendance: Building Administrator Judy Thomas and Board Clerk Fran Howell.

- 4. Agenda Adoption: With the addition of a change to Action Item #1 Motion to accept third reading of Policy 3575 (not 8220 \$\overline{\text{\text{M}}}\$ 8250) and an addition of Action Item #2, Motion to adopt the 2015 Idaho Special Education Manual, Chairman Hicks called for a motion to adopt the amended proposed agenda.
