Smart Snacks in Schools is in Effect - On July 1, 2014, USDA's Smart Snacks in Schools went into effect. This policy is part of the Healthy Hunger Free Kids Act of 2010 and applies to all foods sold to students on campus during the school day. This includes foods sold in vending machines, a la carte items in the lunchroom, in-school fundraisers, and in school stores. The goal of Smart Snacks in Schools is to provide students with healthier choices for all food sold to them during school, thus contributing to improving the overall health of the school environment. The DOE School Nutrition Program team has provided training to all school nutrition supervisors and chief school officers on this regulation. Compliance with Smart Snacks is reviewed during School Nutrition Program Administrative Reviews. ### **Quality Improvement**

Chapter 5, Delaware School Nurse Manual - School Health Services is pleased to announce that Chapter 5, Quality Improvement, in the newly revised and updated Delaware School Nurse Manual, has been completed and posted online. The content of the final chapter is based on the National Association of School Nurses' Framework for 21<sup>st</sup> Century School Nursing Practice<sup>TM</sup> [Framework]. Sections within the Chapter include: Document; Data Collection, Utilization, & Research; and Evaluation. The concept of Quality Improvement is not new to school nurses, but examining it as a competency or skill is somewhat new and much less developed than the other principles within the Framework. Thus, it should be no surprise that over 80% of the content in this chapter is new and was not included in previous editions of Delaware's manual for school nurses.

**eSchoolPlus Help Desk** - The DOE eSchoolPlus Help Desk is available to districts and charters when assistance is needed regarding the program. The Help Desk is currently staffed by Dan Mize, Mary Nardo, and Andrew Cronk. Their number is 735-4140. However, all school nurses using eSchoolPlus must first contact their district technology staff for assistance. While the question may be a new one to the individual school nurse, it is likely not something new for the technology staff. If they are unable to resolve the problem, they will contact the DOE Help Desk. We believe this will facilitate a prompt response for you and build district/charter level capacity for assisting with eSchoolPlus. # **Standards of Practice**

**Delaware School Nurse Manual** - School Health Services is extremely pleased to announce that the new *Delaware School Nurse Manual* is now complete and posted online. The *School Nursing: Technical Assistance Manual* has been entirely removed from the website. If school nurses have hard copies of the former manual, they are urged to destroy them so that there is no confusion for the nurse or a substitute on what resource has been provided by the Delaware Department of Education. The website page, <u>Delaware School Nurse Manual Forms</u>, providing forms from the Manual has been updated with new and revised forms. School nurses should be cognizant of what is expected as articulated within the State's guidelines for practice.
