

In Algebra 1, instructional time should focus on five critical areas:

Area 1- Expressions and Equations

a. By the end of this unit, students will be able to interpret the structure of expressions and create equations that describe numbers or relationships.

Area 2- Reasoning with Equations and Inequalities

a. Students will understand solving equations as a process of reasoning and explain the reasoning. Solve equations and inequalities in one variable. Represent and solve equations and inequalities graphically.

Area 3- Linear Functions

a. Students will understand the concept of a function and use function notation, interpret functions that arise in applications in terms of the context.

Area 4- System of Equations and Inequalities

a. Students will understand prove a given system of two equations with two variables, replacing one equation by the sum of that equation and multiple of the other produces a system with the same solutions.

Area 5- Exponential Functions

a. Students will understand distinguish between situations that can be modeled with exponentials functions. Construct exponential functions given a graph, sequence, or a table of values.

The **Mathematical Practice Standards** describe the expertise that mathematics teachers should develop in their students. Teachers should consciously plan for aligned instruction with 1-2 practice standards embedded in each lesson.

Student Friendly Mathematical Practice Statements

MP.1.1 Make sense of problems and persevere in solving them.

- Make a plan!
- Try different approaches when your problem is hard.
- Solve your problem in more than one way.
- Check whether your solution makes sense.

MP.2.1 Reason abstractly and quantitatively.

• Explain the meanings of the numbers, words, pictures, symbols, and objects you and others use.

MP.3.1 Construct viable arguments and critique the reasoning of others.

- Explain both what to do and why it works.
- Work to make sense of others' mathematical thinking.

- Apply math to real-world situations.

Speaking and Listening

- a. Come to discussions prepared, having read and researched material under study; explicitly draw on that preparation by referring to evidence from texts and other research on the topic or issue to stimulate a thoughtful, wellreasoned exchange of ideas.
- b. Work with peers to set rules for collegial discussions and decision-making (e.g., informal consensus, taking votes on key issues, and presentation of alternate views), clear goals and deadlines, and individual roles as needed.
- c. Propel conversations by posing and responding to questions that relate the current discussion to broader themes or larger ideas; actively incorporate others into the discussion; and clarify, verify, or challenge ideas and conclusions.
- d. Respond thoughtfully to diverse perspectives, summarize points of agreement and disagreement, and, when warranted, qualify or justify their own views and understanding and make new connections in light of the evidence and reasoning presented.

- d. Establish and maintain a formal style and objective tone while attending to the norms and conventions of the discipline in which they are writing.
- e. Provide a concluding statement or section that follows from or supports the argument presented.


