



Mathematics: Algebra 2 Draft

In Algebra 2, instructional time should focus on four critical areas:

Area 1- Real Number System

- a. Extend the properties of exponents to rational exponents.

Area 2- Structure in Expressions

- a. Interpret the structure of expressions and write expressions in equivalent forms to solve problems.

Area 3- Polynomials and Rational Expressions

- a. Understand the relationship between zeros and factors of polynomials

Area 4- Reasoning with Equations and Inequalities

- a. Understand solving equations as a process of reasoning and explain the reasoning. Represent and solve equations and inequalities graphically.

Area 5- Interpreting and Building Functions

- a. Interpret functions that arise in applications in terms of the context. Build functions that model a relationship between two quantities.

- b. A-SSE.A.2, B.3, B.4

The **Mathematical Practice Standards** describe the expertise that mathematics teachers should develop in their students. Teachers should consciously plan for aligned instruction with 1-2 practice standards embedded in each lesson.

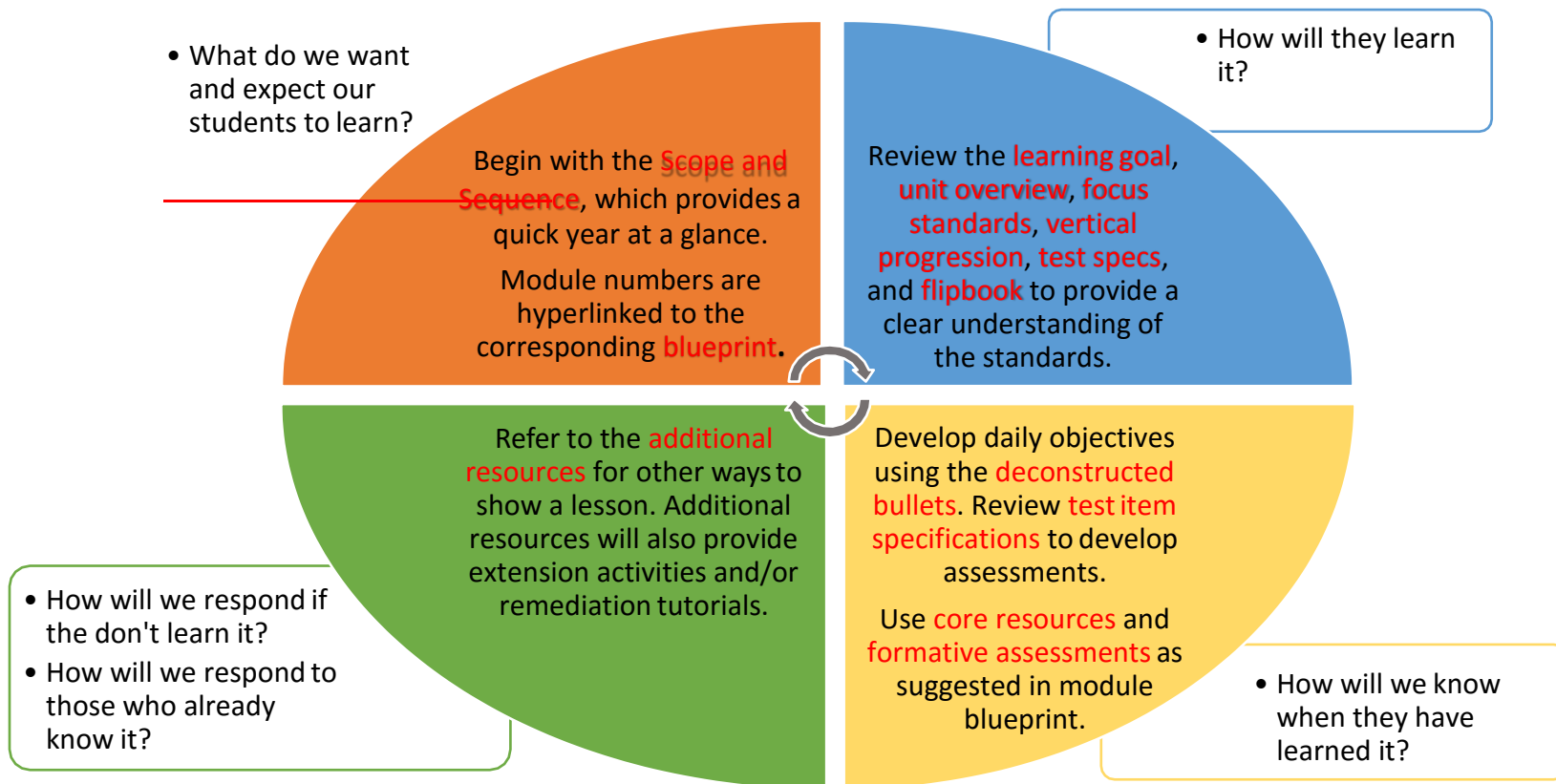

Each Unit correlates with a Unit in the adopted text book for the course. A date range has been given for each Unit. The date range has an extra day or two to allow for assessing the students. Holidays and teacher work days were accounted for when date ranges were determined. Please pay attention to date ranges that have Midterm Exams at the end. There is a week for FSA/EOC review before the testing window opens up. This week can be used to finish teaching if you get behind.

The adopted resources for Algebra 1, Geometry and Algebra 2 have assessments for each Module and each Unit. This allows teachers to assess students twice on material through a Module Assessment and a final Unit Assessment if they so choose to.
