1. **CALL MEETING TO ORDER:** Chairman Scholes called the meeting to order at 7:05pm and led the board and audience in the Pledge of Allegiance.

3. **ACTION ITEMS:**
 - a. Chairman Scholes called for a motion to adopt the proposed agenda. Mrs. Poole so moved. Mrs. Hulse seconded. The motion passed unanimously.

6. ACTION ITEMS:

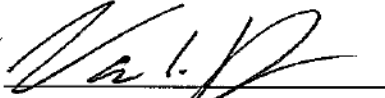
