Homework: Homework is defined as anything that is not completed in class, and occasionally, an assignment they will need to complete on MyLearning.

<u>MyStudent:</u> MyStudent is an online gradebook that parents and students should access the most official grades. The grades are linked to Mylearning Canvas and will be updated weakly and/or after a major assessment.

<u>MyLearning</u>: MyLearning is our online platform utilizing Canvas as many students did last year. Everything we do in class will be located here with minimal exception.

Quarantine: If a student is absent for a length of time due quarantine, all classroom materials may be found on Mylearning as well.

<u>Tests & Quizzes:</u> There will be periodic tests and quizzes, which will consist of fill-in the blank, short answer, multiply choice and/or true and false. The policy for retakes requires that the student complete teacher-determined reteach, and has completed all missing activityassignments leading up to original assessments. Students will earn the highest grade obtained. Semester and EOC Exams are excluded from this policy.

Notebook: Students are to keep an interactive notebook that contains all notes and certain assignments that aid in mastering the information. Students can and will use this to help study and build their knowledge towards world history standards.

Document Based Questions: We will do several DBQ type assignment this year. Analyzing primary and secondary sources followed by an essary or product based assessment.

Make-up Work Policy: Make-up work is defined as work missed during an excused absence. Students will need to review Mylearning to find this information or ask Mrs. Skaggs for a paper copy when available.

Late Work Policy: Late work will be accepted at a flat rate of 20% off if the assignment is done well. This means late work will start at 80%. Absences and guarantine will be taken on a case by case basis.

Electronic Policy: Students will ocassionally be able to use their technology for educational purpose. Unless the whole class is using technogy, the student will be required to ask permission, if they need to do something on MyLearning for history or look something specific up. I usually follow the latter up with probing questions about what they learned from their research.

*When not in use, each student will have a numbered slot they can get their devices at from the phone cady that each of our Unstopables team teachers use.
