****Info for AP and Dual Enrollment Students:** Students enrolled in AP US History or Dual Enrollment US History cannot complete the US History EOC assessment. Students in AP American Lit or Dual Enrollment American Lit must take the EOC. Students in AP Biology or Dual Enrollment Biology will only take the EOC if they have NOT previously completed the core high school Biology course. **AM = Morning Session, PM = Afternoon Session.**

Spring 2022 Georgia Milestones Assessments

Students enrolled in **Algebra I, American Literature & Composition, Biology, and U.S. History** courses will report for testing on the days shown above. Both **face-to-face students and virtual-only students** are required to complete the EOC if they are enrolled in an EOC-affiliated course, and the EOC is required by state law to count as **20% of the final course average.**

Reporting to Campus for Testing

Our virtual students must report to campus to take an EOC as the state does not offer an online version that can be administered at home. **Parents/Guardians of virtual students are responsible for providing transportation to and from the student’s districted school for testing.**

Virtual students with extended time accommodations via an IEP, 504, or TPC will test in the morning of that day’s EOC beginning at 8:35 am. These AM Testers should report to PCHS at 8:00 am. Students may be dropped-off at the front of the school and should report directly to the Media Center.

All other virtual students will test in the afternoon, beginning no later than 12:00 pm. PM Testers should report to PCHS at 11:30 am. Students may be dropped-off at the front of the school and should report directly to the Media Center

After testing, virtual students will be dismissed from the media center and be allowed to call home for pick up.

If PCHS is not your home school, contact your virtual teacher or your home school for the correct information.
