














WHY DOES THIS DAY LIVE IN INFAMY?

- What was it? Attack on the U.S. Military forces in Hawaii. Happened on U.S. soil
- When was it? December 7, 1941
- What was its purpose? Japan wanted to cripple the U.S. military (Navy)in the Pacific Ocean, so that Japan could take over more land in the Pacific.
- Was the plan effective? Short-term it was effective (U.S. lost over 150 ships) Long-term it was not effective, because the U.S. declared war on Japan and got involved in WWII.
- How was it an influence on U.S. entry into WWII? It was the direct reason why the U..s became involved in the war. After Pearl Harbor more people supported the war.

Marietta, GA

Montin AFB

B-29 bomber, America's most technologically advanced bomber in the war

Produced 650 bombers before the end of the war

Biggest impact – 30,000 people were employed by the larges plant to have ever been build in the Deep South

Closed after the war – Reopened in 1951 as Lockheed Martin




Major contribution during the war










Franklin Delano Roosevelt built the Little White House in 1932 while governor of New York, prior to being inaugurated as president in 1933. He first came to Warm Springs in 1924 hoping to find a cure for polio that had struck him in 1921. Swimming in the 88-degree, buoyant spring waters brought him no miracle cure, but it did bring improvement. During FDR's presidency and the Great Depression, he developed many New Deal Programs (such as the Rural **Electrification Administration**) based upon his experiences in this small town.



The Holocaust was the systematic mass murder of over 6 million Jews is Europe. The Nazis used Concentration Camps to imprison, work, and execute Jews, gypsies, homosexuals, and political dissidents. The Holocaust had an impact on the state. Many Holocaust survivors moved to Georgia after the war. Their stories about the horrible events in Europe touched the lives of many Georgians. The Holocaust also made some Georgians rethink their treatment of minorities in the state. Though it took more than a decade for the modern civil rights movement to gain momentum in Georgia and the rest of the South, the horror of what happened in Europe made Georgians "look in the mirror" and reexamine their racial practices. In addition, former Governor Joe Frank Harris, established the Georgia Commission on the Holocaust to educate people about the Holocaust therefore creating an awareness of the events.



The Transformation of Agricultures

- Several factors caused Georgia's population to shift from rural to urban areas.
- Destruction of cotton crop by the boll weevil and the drought
- Migration of African-Americans to northern cities
- Movement of blacks and whites to Georgia's industrial centers and factories during both World Wars
- AAA paying farmers to stop growing crops



The Transformation of Agricultures

- Another factor impacting agriculture in Georgia after World War II was the technological change in agricultural equipment.
 - Tractors, reapers, and other machinery
 - Better fertilizers
 - Made it easier to grow and process crops
- Lessened need for large numbers of agricultural workers





The Transformation of Agricultures

• Though the rural population in Georgia has decreased from almost 85% in 1900 to less than 25% today, farming is still important to Georgia's economy, bringing in \$56 billion a year to the state (approx. 16% of total)

William Hartsfield

- Atlanta City Council- 1922
- Helped in opening Atlanta's first airport
- Atlanta Mayor- 1937-1941; 1942-1961
- Longest serving mayor
- Helped city make it through depression- talked president of Coca
 Cola into paying payroll one month
- Helped keep city calm during integration
- Known for starting statement that Atlanta was "The City too Busy to Hate"
- Tripled Atlanta's size, oversaw building of many of Atlanta's parks, expanded Atlanta's expressway system.




Ivan Allen Jr.

- Mayor of Atlanta- 1962-1970
- Fought for Civil Rights
 - On his first day as mayor, he had all the white and colored signs removed from city hall and desegregated the building's cafeteria.
 - Worked with Martin Luther King Jr. and Atlanta's business leaders to help the city transition smoothly into desegregation
- Helped improve Atlanta's transportation
 - Interstate 285
 - M.A.R.T.A.




Ivan Allen Jr.

- Best known for bring helping bring major league sports to the city.
- He convinced Atlantans to financially support the construction of stadiums and brokered deals to bring the Braves and Hawks to Atlanta
- Persuaded NFL to start new franchise in the city







Major League Sports

- Atlanta's sports teams have brought thousands of jobs to the state and millions of dollars into the economy.
- Their facilities helped bring the 1996 Olympic games to the state of Georgia.
- The first team to come to Atlanta was the Atlanta Braves in 1966. Followed by the Falcons the same year and the Hawks in 1968.





The Braves are often considered to be the oldest professional sports team in the United States.

Which cities and teams did they belong to before moving to Atlanta?

Atlanta Braves

• They trace their origins back to the 1869 Cincinnati Red Stockings that moved to Boston in 1871 and then to Atlanta.

• The Braves were one of the most successful teams in the 1990s. Unfortunately, they were also the second team in Major League Baseball history to lose 10,000 games.




Major League Sports

 Atlanta is also home to other professional sports teams including men and women's soccer and women's basketball.

Atlanta is also the only city to lose two National Hockey League teams: The Atlanta Flames and the Atlanta Thrashers





Ellis Arnall

Ellis Arnall



- 1932- Georgia General Assembly
- 1938- Georgia Attorney General- At age 31, he was the youngest attorney general in the United States.
- 1942- Governor- Defeated Eugene Talmadge largely due to the state's university system losing its accreditation because of Talmadge's interference.
- As governor, he is credited with
 - Restoring accreditation to the state's colleges
- Abolishing the poll tax
- Lowering the voting age
- Establishing a teacher's retirement system




With all the positive things that Arnall did, why was he unpopular with Georgia voters during this time period?

Ellis Arnall

- Lost support in the state based on his support of lavand rulings that supported Civil Rights for African Americans
 - Example- He accepted the Supreme Court ruling against the white primary.
- Due to Georgia law, he could not run for re-election in 1947. He played a key role in the "three governor's controversy (coming soon) by refusing to give up the governor's office until the issue was worked out.
- He ran for Governor again in 1966, but lost in the primary to segregationist Lester Maddox. He never ran for office again.
