Seamless Summer Option

The Seamless Summer Option (SSO) is a neighborhood based program that uses site and area eligibility to provide nutritious meals to children during the summer months. It is an extension to the National School Lunch Program (NSLP) and School Breakfast Program (SBP) which operates during the school year.

From June 10, 2024 to July 19, 2024, Pearl City HS will serve meals free of charge to children ages 18 years and younger, regardless of public school enrollment status, through SSO Monday through Friday, excluding state holidays (King Kamehameha Day - June 11th, Independence Day - July 4th). Breakfast will be served from 7:15 a.m. to 8:45 a.m. and lunch will be served from 10:30 a.m. to 12 p.m. Meal recipients do not have to be enrolled at a participating school to be served and meals must be consumed in the dining area.
