I. Charter School Program

Sussex Academy is a small accelerated charter school located in Georgetown, Delaware which is in the geographic center of Sussex County. The school opened in 2000 as a middle school for grades 6-8. In 2013, the school moved physically to a new building and began its first ninth grade class with a four year phase-in for high school. Sussex Academy had its first graduating class in June 2017. Because of its centrality and its academic program, parents view Sussex Academy as a choice to some of the larger schools in the county. Sussex Academy's mission is to foster academic achievement and social responsibility through a challenging curriculum, highly effective instruction and a respectful, responsible school culture. Sussex Academy is certified as an International Baccalaureate World School with the IB Diploma program.

Discuss Key Accomplishments of the Charter School Program Over the 2016-17 School Year.

In school year 2016-2017 Sussex Academy students continued to meet and exceed the standards as measured by international, national, and state benchmarks in English Language Arts, mathematics, and science. After a four-year phase in of the high school, Sussex Academy saw its first graduating class in June 2017. Of the 39 graduates, 38 were slated to attend college and one entered the military. By mid summer we learned that of the thirteen students who had enrolled in the full IB diploma program, that seven of the students earned the IB diploma. The IB system is Juried, as the measures are international and scored by those outside the school. Sussex Academy students pride themselves on the numbers of community service hours they complete with each middle school student having to complete 10 hours and high school students having to complete a minimum of 25 hours during the school year. Sussex Academy also saw the fielding of middle school, junior varsity, and varsity athletic teams in field hockey, soccer, basketball, volleyball softball, baseball, golf, and swimming. In addition, the high school arts program has had several high successful choral, band and theater productions. The school was delighted to host the DIAA Henlopen Conference swim meet at our newly opened state of the art aquatics center that was a gift from the Schell Brothers of Rehoboth, Delaware. Additionally, Sussex Academy Foundation completed all phases of the school facility and by year's end was waiting for the completion of an outside concession stand with bathrooms, storage, and training room.
