# To help the poor, the help debtors, to provide defense from the Spanish, to provide charity, to help England get rich

3. Who were some of the potential enemies that posed a threat to Georgia and the Carolinas?

#### The Spanish in Florida, the French in Louisiana and the Native Americans

4. What restrictions were placed upon the colonists who had received charity?

#### Those who had not paid for their land could not sell the land, or borrow money against it

5. What were some of the policies that upset the colonists?

# Restrictions on land buying/selling, not allowing slavery, not allowing rights of other Englishmen

# **Document A Analysis**

1. What were some of the occupations of the first settlers of Georgia?

## Silkmakers, merchants, carpenters, etc.

2. Why did the Trustees specifically choose some of these worker skills to settle Savannah?

# These trades were needed in order to get the colony started; build homes (carpenters), grow and harvest the silk (farmers and silk makers)

3. What happened to many of the first settlers within a few years of their arrival? What reasons can you think of that might have led to their fates?

# Died of disease, fled the colony

4. Why do you think there were many more settlers for whom the Trustees paid their way in comparison to those who paid their own way?

# The trustees needed those skilled workers who were dependable, had families, and could help establish the new colony

## Marking Jenkins by severing his ear was a permanent reminder of his capture

Jenkins hoped to spark outrage at the treatment of an Englishman by the Spanish

3. Examine the map provided. What conclusions can be drawn regarding the locations of British and Spanish forts along the Georgia and Florida coasts?

The forts were close and each fort was established an approximate equal distance apart by both the British and the Spanish.

# the southern location and warm climate of GA: similar latitude as Asia

Latin for "Not for themselves but for others" meaning not for themselves, but possible for the debtors (if from the perspective of the trustees) or possibly for the King (economically---mercantilism).

Charity: "...it will be highly conducive for accomplishing those ends, that a regular colony of the said poor people be settled and established in the southern territories of Carolina..."

Economics: "...the settle in any of our provinces in America where by cultivating the lands, at present waste and desolate, they might not only gain a comfortable subsistence for themselves and families, but also strengthen our colonies and increase the trade, navigation and wealth of these our realms..."

Defense: "...we think it highly becoming our crown and royal dignity, to protect all our loving subjects, be they ever so distant from us; to extend our fatherly compassion even to the meanest and most unfortunate of our people..."

2. What was the intended management structure of the colony?

## Trustees managed the colony

3. The men listed in the charter were to serve in a capacity for the colony. What was it?

20 men PLUS Oglethorpe were appointed as the trustees of the GA colony
