Registration - What Will You Need?

Ш	School registration form
	Registration forms may vary from school to school. Be sure to check!

- ☐ Birth Certificate
- ☐ Social Security number
- DSCYF letterhead statement as proof of residency for a child in foster care with placement resource identified.
- ☐ Custody/Guardianship Order
- ☐ Sign a request for release of information DSCYF should sign this form for children in foster care.

For children covered under McKinney-Vento, which includes children in foster care, enrollment will not be delayed if all items are not currently available.



Registration

☐ Provide medical records including up-to-date immunizations, current physical (within two years) & information on chronic health conditions.

DSCYF should provide this information. The school nurse may be able to assist.

☐ Share medical information (medications, allergies, history, etc).

Foster Parents – Consider using the Medical Transfer Instruction Sheet. Schools – Consider using a "health history update form".

☐ Share copies of relevant records (report cards, transcripts, Individualized Education Program or IEP, 504 accommodation plan, etc.).

These records may be shared electronically or by fax.



McKinney-Vento Homeless Assistance Act "Best Interest" Discussion

Each school district has a homeless liaison who is responsible for arranging "best interest" discussions:

- At registration
- At the end of the school year

For children in foster care, DSCYF is responsible for arranging the "best interest" discussion when there is a change of placement.

DSCYF is always responsible for inviting relevant case participants.

Discussions (which may be by phone) and meetings should be documented. (*Appendix E of Memorandum Of Understanding*)



McKinney-Vento Homeless Assistance Act "Best Interest" Discussion

Best Interest discussion includes:

- ☐ Child safety
- ☐ Child wishes
- ☐ Parent wishes
- Physical & mental health of child
- ☐ Child's adjustment to foster placement, school & community
- ☐ Child's educational needs
- ☐ Child's disability or special needs
- ☐ Distance of commute to school
- ☐ Permanency plan
- ☐ Discussion is documented on Feasibility of School Placement Form (*Appendix E of Memorandum Of Understanding*)





Additional Information You May Receive When You Register Your Child

- Emergency contact card
- ☐ Free/reduced breakfast/lunch information
- ☐ List of School Supplies needed

 Some schools may be able to help provide

 supplies, so don't hesitate to ask!
- ☐ School handbook/code of conduct



School policies vary so please check your school's handbook/code of conduct.

All handbooks are on school district websites!

- ☐ School mission
- □ School calendar
- ☐ Guidelines for conduct
- ☐ Attendance/Absence policy
- ☐ School activities

- ☐ Dress code
- □ School counselors/advisors
- ☐ School services/programs/policies

- ☐ Graduation requirements
- □ PTA/PTO/Family Involvement Information





What Does the School Need to Do?

Request records from other schools Review medical information and determine areas of need Arrange transportation Transportation may take 3-5 days to arrange. Make assignment to a classroom and/or academic schedule Scheduling typically takes 2 days to arrange. Follow procedures for children in foster care Children in foster care are considered "homeless" under the McKinney Vento Homeless Assistance Act



Tips for Success!

- ☐ Visit your school's website find a link to all school websites and school information http://www.doe.k12.de.us/
- ☐ Learn about your child's school.
- ☐ Share information.
- ☐ Find the best way to communicate with your child's teacher.
- ☐ Work with your child's teacher to resolve issues.
- \Box Ask questions ask for help.
- □ Talk to your child's teacher talk to your child.
- ☐ Keep records about your child.
- Encourage learning and positive behavior at school.
