High School Summer School

Program Explanation

The High School Title IV is designed to allow 9th and 10th grade students the opportunity to earn credit English Language Arts (9th & 10th Grade Lit/Comp) and Science (Biology, Physical Science, Earth Systems and Environmental Science) courses they attempted and did not pass. This intense three-week program will use Apex Learning as the platform.

Who Can Attend

The program is open to 2018-19 9th & 10th Grade students enrolled in Forsyth County Schools. **Students who need to attend Math** Academy are not eligible for Title IV Summer School.

Dates and Times

Monday, June 3 - Thursday, June 20. Classes are held Monday - Thursday from 8:00 a.m. to 1:00 p.m.

Location

Classes will be held at each of the Forsyth County High Schools.

Class Size

Average student teacher ratio is 20:1.

Registration Procedures and Dates

All registrations must be done at the student's base school by a counselor or designee. Counselors must complete an online registration form for each student. Registrations will be accepted from Monday, May 6th – Friday, May 31st.

Cost and Payment

There is no cost for Title IV Funded Summer School.

Attendance

Students have a limited time to complete the coursework; therefore, daily attendance is critical and required. The Title IV Summer School director has the authority to withdraw students for lack of attendance.

Grading Procedures

When a student fails and then retakes the same course, both courses and both grades are posted on the student transcript. Retaking and passing the course *does not* replace the failing grade.

Georgia Milestones End of Course (EOC)

EOCs for 9th Lit/Comp, Physical Science and Biology will be administered prior to the final day of class. Students must be in attendance to receive credit for the course

Behavior and Dress Code

Title IV Summer School classes are conducted in a business-like environment. Students are expected to treat all staff and other students with respect and follow the FCS Student Code of Conduct and appropriate computer use. Students are expected to dress appropriately for a school setting. Failure to comply may result in removal from the program, solely at the discretion of the Director and cannot be appealed.

School to Home Communication

Much of the communication from the school to home during the summer school will occur via email. This includes information prior to the start of the course, attendance information, and progress updates during the period of time that classes are being held. Please be sure to provide an email address during the registration process that is monitored daily.

Transportation / Drop Off and Pick Up Area / Parking

Students are responsible for their own transportation. Parents who provide transportation must drop off their child no earlier than 7:45 a.m. and must pick them up no later than 1:15 p.m.
